## Expenditure – Darwin Middle School

1. Please provide the details of the total expenditure at Darwin Middle School for the period 27 August 2016 to 30 June 2021 for the purposes of upgrades, fit outs, improvements, major and minor works, refurbishments and construction, landscaping and all associated works.

During the specified period \$225M has been expended across all schools for Capital Works projects with \$11.87M expended at Darwin Middle School.

Darwin Middle School is a newer school in Darwin, built to cater for the significant increase in student population in the city. In 2020, Darwin Middle School had 866 enrolled students.

Construction of the school was completed in January 2008. The school opening was staged with years 7 and 8 in 2008, and year 9 commenced in 2009.
