### **OUTSOURCING**

In February 2022, the Northern Territory Police, Fire and Emergency Services (NTPFES) received approval from the Chief Executive Officer of Department of Environment, Parks and Water Security to use Contract Q21-0247 – Darwin – Supply and Delivery of Accredited Training to Bushfires NT staff and volunteers for a period of 24 months. The ability to utilise Q21-0247 alongside the existing NTPFES volunteer training resources, will significantly increase the ability for the NTPFES to deliver necessary training to volunteers that will enhance community safety regarding fire and emergency management and preparedness.

To date, the NTPFES has not used the contract services. Planning is occurring to use the contract alongside existing NTPFES resources to augment capacity from June 2022 onwards on an 'as needs' basis.
