# Minutes of Proceedings

# LEGISLATIVE ASSEMBLY

No. 35

Wednesday 31 March 1976

- The Assembly met at 1000 hours, being the time fixed by Mr Speaker pursuant to the Resolution of 25 February 1976 Mr Speaker MacFarlane took the Chair.
- DECLARATION OF CAUSE OF CALLING ASSEMBLY TOGETHER: Mr Speaker made the following statement:

"This meeting of the Assembly has been summoned in accordance with the terms of the resolution of February 25 following the failure of the Acting Administrator to declare his assent to or to reserve for the Governor-General's pleasure, the Criminal Injuries (Compensation) Ordinance 1975.

In interpreting the resolution, I accepted delays of much more than the 48 hours proposed by the Honourable Member who sponsored the resolution but I cannot continue to disregard the Acting Administrator's failure to act on this Ordinance which was passed by the Assembly on December 4, 1975."

3. FAILURE OF ACTING ADMINISTRATOR TO COMPLY WITH ACT: Dr Letts, by leave, moved - That this Assembly express, in the strongest possible terms, its disapproval of the failure of the Acting Administrator to comply with the requirements of the Northern Territory (Administration) Act in respect of Ordinances made by this Assembly and presented to him for assent.

Dr Letts was granted leave to continue his remarks on the resumption of the debate.

Debate adjourned and the resumption of the debate made an order of the day for a later hour.

- 4. QUESTIONS: Questions without notice were asked.
- 5. ALLEGATIONS RELATING TO BY-ELECTION FOR THE ELECTORATE OF ALICE SPRINGS: The following letter was tabled by Mr Speaker:

Dear Mr MacFarlane,

I refer to your letter dated 18th February 1976 relating to allegations at the recent by-election for the Electorate of Alice Springs.

It was alleged that Mr Manuell a candidate at that election entered a polling booth without the permission of the Presiding Officer and handled the ballot box.

The Chief Australian Electoral Officer has investigated the allegations and, while the investigation indicated that a minor technical offence did occur when Mr Manuell entered the booth without the permission of the Presiding Officer and spoke to the Country Liberal Party scrutineer, he apparently quit the booth within a reasonable time when requested to do so. The allegation of handling the ballot box is in conflict with the evidence of the Polling Officials.

The Chief Australian Electoral Officer has written to Mr Manuell drawing his attention to the requirements of the law but because of the nature of the offence, the Chief Australian Electoral Officer believes that no further action is warranted in this instance.

- ADDITIONAL REASONS FOR CALLING ASSEMBLY TOGETHER: Dr Letts, by leave, made a statement relating to further reasons for calling the Assembly together.

- 3. in keeping with the principles and practices adopted within Australia's Federal system and in keeping with the policy of future statehood for the Northern Territory the Assembly should play its proper part in the making of such legislation as it

has done in the past, and as would be the case in the States;

4. as the 1967 referendum concerning Australian Aborigines and the subsequent amendments to the Constitution made no change in the relationships between the Federal and Territory legislatures, there is no case now to deny the Assembly its proper role in making land legislation.

Dr Letts was granted leave to continue his remarks on the resumption of the debate.

Debate adjourned and the resumption of the debate made an order of the day for a later hour.

8. DISCUSSION OF MATTER OF PUBLIC IMPORTANCE: Mr Speaker informed the Assembly that Mr Tambling had proposed that a definite matter of public importance be submitted to the Assembly for discussion, namely: "The effects of the Federal Government's financial policy on the present economy and future development of the Territory.".

The proposal having received the necessary support - Mr Tambling addressed the Assembly.

Discussion ensued.

SUSPENSION OF SITTING: The sitting was suspended between 1147 and 1400 hours.

FAILURE OF ACTING ADMINISTRATOR TO COMPLY WITH THE ACT: The order of the day having been read for the resumption of the debate on the motion of Dr Letts, That this Assembly express, in the strongest possible terms, its disapproval of the failure of the Acting Administrator to comply with the requirements of the Northern Territory (Administration) Act in respect of Ordinances made by this Assembly and presented to him for assent.

Debate resumed.

Question put and passed.

12. ADJOURNMENT: Dr Letts moved - That the Assembly do now adjourn.
