The Leader of Government Business (Mr Elferink) informed the Assembly that the government accepted the motion as a censure motion, pursuant to Standing Order 95.

The Order of the Day having been read for the resumption of debate on the motion moved by the Member for Karama (Ms Lawrie) – That the Assembly censure the Chief Minister and his Government for lying to Territorians by promising to cut the cost of living and then increasing PowerWater bills by \$2000 per family and \$7800 per small business from January 1 next year.

Debate resumed.
