Mr Wood moved – That:

- 1. The bill be referred to a select committee to be called the 'Select Committee on the Alcohol Protection Orders Bill' for inquiry and report, including consideration of other possible models for achieving the objects of the Bill;
- 2. The Members of the Committee shall be three Members nominated to the Speaker in writing by the Government Whip, two Members nominated to the Speaker in writing by the Opposition Whip, and Mr Wood;
- 3. The Committee shall report to the Assembly by the first sitting day in May 2014;

- 4. The Committee may elect a Deputy Chair of the Committee, who may act as the Chair when the Chair is absent from a meeting or there is no Chair of the Committee;
- 5. A quorum of the Committee shall be three members of the Committee; and
- 6. This resolution shall have effect notwithstanding any contrary provision of the Standing Order.

Debate ensued.

Bill to be reported with amendments.

The Assembly resumed; the Speaker (Ms Purick) took the Chair; Mr Higgins (Chair of Committees) reported that the Committee had agreed to the Bill with amendments.

Madam Speaker put the question - That the Report be adopted.

Motion agreed to.

On the motion of Mr Giles, the Bill was read a third time and was passed to be a proposed law.
