SUBORDINATE LEGISLATION NO. 16 OF 2017

**CARE AND PROTECTION OF CHILDREN (SCREENING) AMENDMENT
REGULATIONS 2017**

Purpose

The *Care and Protection of Children (Screening) Amendment Regulations 2017* increases fees and charges in relation to the provision of a clearance notice or replacement clearance notice.

Summary of key provisions

As part of the 2017-18 Budget, the Northern Territory Government increased all legislated fees and charges by 20% where revenue is returned to the Central Holding Authority. An amendment to the *Care and Protection of Children (Screening) Regulations* is required to give effect to the fee increases as follows:
