Answer:

As at 14 June 2012, there were 27 unoccupied public housing dwellings in the electorate of Braitling.

The 27 vacant dwellings consisted of:

- 22 dwellings were undergoing upgrades or repairs, predominantly major works, with an average total vacancy period of 65 days.
- 3 dwellings have been approved for sale.
- 2 dwellings were recently vacated and were awaiting assessment of the maintenance work required prior to being reallocated to new tenants.

A detailed list of dwellings is attached.

In addition, as at 14 June 2012, 18 dwellings were newly completed at the Larapinta Seniors Village and became available for allocation on 6 June 2012.
