Answer:

There were three reviews undertaken during the 2019-20 financial year as detailed below:

Correctional Services

Two reviews were undertaken during the 2019-20 financial year, both relate to the events of a break out of accommodation and concerted indiscipline on 13 May 2020. For security reasons details of the investigations cannot be provided.

Regulatory Services

A joint investigation into the affairs of the Darwin Greyhound Association and the Greyhound Industry more generally by the Racing Commission and the Commissioner for Consumer Affairs. The law firm Hutton McCarthy was engaged on 4 June 2020 to conduct the investigation.

- a) Terms of Reference

Undertake an investigation in to matters relating to greyhound operations and associations obligations and produce a report:

The Investigator is in accordance with the principles of procedural fairness:

- i. To investigate whether Darwin Greyhound Association is operating their association in accordance with the *Associations Act 2003*, appropriate governance and business practice and standards, and meeting obligations as set out in their NT Government funding agreement.
- ii. To investigate whether the Darwin Greyhound Association is compliant with building/construction, tenancy and other laws in relation to the Darwin Greyhound Association premises located at 15 Hook Road Winnellie.
- iii. To investigate whether the Greyhound Industry in the Northern Territory has sufficient policies and procedures to ensure best practice animal welfare standards are being adhered to

- iv. To investigate whether additional policies, procedures or guidelines are required for Darwin Greyhound Association to meet their obligations under the *Racing and Betting Act 1983*.
 - v. To investigate whether the constitution adequately addresses, and is consistent with, the greyhound rules.
 - vi. To investigate specific claims with regard to a complaint dated 20 August 2018.
 - vii. To note any additional information that may be relevant to the regulation of Greyhounds in the Northern Territory that is not addressed above.
 - viii. Consider all available evidence and document the investigation.
 - ix. Where there are contentious facts, a recommendation is made as to which evidence is to be preferred, the reasons for preferring that evidence over other evidence should be clearly set out.
 - x. To complete a report on the findings of the investigation including any recommendations and directions to the Management Committee of the Darwin Greyhound Association.
- b) Relevant knowledge of the subject matter and experience in procurement were the criteria for panel selection.
 - c) Law firm Hutton McCarthy was selected via the Legal Services List managed by the Solicitor for the Northern Territory having due regard to their local presence and experience across the greyhound industry.
 - d) The contract value for the review is \$72,000.
 - e) Hutton McCarthy will accumulate information to contribute to the investigation through the following methods:
 - Direct consultation with industry stakeholders including the Association and NT Government representatives engaged in the industry.
 - Review of existing NT legislation and greyhound racing rules governing the greyhound industry.
 - Review of existing NT licence conditions, licensing agreement, funding agreements.
 - f) Not yet completed.
 - g) The final report is expected February 2021.

WORKPLACE HEALTH AND SAFETY

44. Please provide the number, nature and cost of reportable safety issues for the period beginning 1 July 2019 and ending 30 June 2020.

Answer:

From 1 July 2019 to 30 June 2020 there were four notifiable work health and safety incidents in the department.

The nature and cost of the incidents:

1. 15 July 2019 – A cable holding the sally port door snapped and the door crashed to the ground. No one was injured.
Cost: The only cost related to the cable holding the sally port door and this was absorbed within the Public Private Partnership as an operating defect.
2. 29 January 2020 – Contractor fell from a ladder and was injured.
Cost: Nil
3. 8 May 2020 – A fatal vehicle accident occurred within the facility grounds resulting in the death of a prisoner and is subject to an investigation.
Cost: Not able to be quantified at this time.
4. 13 May 2020 – A disturbance occurred and prisoners started a fire. Multiple prison officers responded to the event with several reporting difficulty seeing and breathing due to the smoke from the fire. Once the incident was contained the staff moved to a smoke free area until they had recovered enough to continue work.
Cost: No workers compensation claims had been lodged as at 30 June 2020.
