 - Part time or the equivalent;
 - On temporary contracts,
 in the Department of Chief Minister on 31 October 2012.

ANSWER

1. Would you please advise how many public servants were employed:

• Full time or the equivalent;	Pay 5	155.11
• Part time or the equivalent;	Pay 5	5.62
• On temporary contracts,	Pay 5	63.20

 in the Department of the Chief Minister on 24 August 2012.

2. Would you please advise how many public servants are employed:

• Full time or the equivalent;	Pay 10	118.89
• Part time or the equivalent;	Pay 10	6.26
• On temporary contracts,	Pay 10	36.30

 in the Department of the Chief Minister on 31 October 2012.

The above figures are extracted from BOXI FTE pay reports.

Note: Differences that are apparent when comparing the staff members in the two pay periods are predominately a result of the new agency arrangements which included the transfer of functions and thus staff to other agencies. The figures above also take into account a broad range of individual staff members' salary variations. Such variations arise from a variety of personal circumstances and include staff occupying full time positions who are granted approval to take maternity leave at half-pay and staff approved for recreation and/or long service leave at half pay in order to extend their period of leave
