# **Suspended Sentences**

1. How many youths are currently on suspended sentences?

#### ANSWER:

As at 30 June 2022, there were 35 youths on either a suspended sentence order or a suspended sentence of detention order.

2. How many youths commenced suspended sentences in the 2021/22 financial year? Please provide a breakdown by region.

### ANSWER:

During 2021-22, there were 49 youths who commenced either a suspended sentence order or a suspended sentence of detention order. The breakdown by region is below:

3. How many youths completed suspended sentences in the 2021/22 financial year? Please provide a breakdown by region.

## **ANSWER:**

During 2021-22, there were 21 youths who completed either a suspended sentence order or a suspended sentence of detention order. The breakdown by region is below:

4. How many youths commenced suspended sentences in the 2021/22 financial year but failed to complete them? Please provide a breakdown by region.

### ANSWER:

During 2021-22, there were 13 youths who commenced either a suspended sentence order or a suspended sentence of detention order, but failed to complete the order. The breakdown by region is below:

5. How many youths reoffended after completing a suspended sentence in the 2021/22 financial year? Please provide a breakdown by region.
