### **RE: Re™ - Submission and objection for Territory Coordinator Bill**

As per our senate objection and submission for no fracking in BEETALOO Basin and AMPIJI WINGA Barossa Basin, we give you no authority, consent or permission to continue this foreign corporate Commonwealth Latin Westminster fraudulent, fabricated, stolen, misrepresentation, distribution, displacement, incarceration, discrimination, harassment, destruction, contamination, racism, apartheid, war, colonial business and the Bill via the proposed Territory Coordinator Act.

This is a crime, breach, judgement and violation against AFT™ Act 2002, and KOOLIN™ Commonwealth™ original and independent Sovereignty, Country and Ancestors, and we request it to be extinguished and ceased. Furthermore, we ask you to respect KOOLIN™ Sovereignty, Countries, Ancestors, knowledge, IP etc. etc. and stop this unlawful and unsustainable Bill and Act which divides, clauses, classes, duplicates, claims, separates, and segregates community, people and the environment for foreign owned criminal and fraudulent business management and or economic environmental sustainability.

Furthermore, we revoke, repeal, recall, reject and rebuke this Bill and Act which will ultimately have to be reset, reformed, renumerated, repatriated and reconstituted for it to be Law-LoRe™ full, sustainable, legal, original, truthful, rightful, and compliant in Right-way Governance, Multicultural Harmony and Holistic Sustainability.
