MY PREVIOUS FITNESS IS MAKING ME PAY, AND A CONVENIENT
HUNGRY CROCODILE WASN'T AVAILABLE ON FRIDAY, WHEN I WAS
TAKEN FOR A RIDE TO THE BEACH. THAT WOULD HAVE SAVED


YOU THIS PAPERWORK. I FOUND OUT THE HOSPICE IS NOW FULL,

I write this now at this time because it's too late for me in any case, and I don't beg... even for mercy. Mercy being what separates us from nature, and as the 'golden rule' states that you do unto others as you would have them do unto you. The notion of mercy is to ease suffering. I've been on radio lately to ask listeners to have this very important conversation to enable agreement that freedom, justice and mercy are mere human constructs, yet define law and empathy and humanity, during the long game...

If you saw and smelled my wound, you would feel my pain and loss of independence. Be careful what you ask

I had made plans to pose as a gardener and escape to join you so that you might see for yourselves what suffering you might choose to grant others in future. I contemplated suicide but its not my style... I'd rather fight for anyone's right to choose a merciful end. My plan is to die in hospice but it's taking too long! My previous fitness is making me pay, and a convenient hungry crocodile wasn't available on Friday, when I was taken for a ride to the beach. That would have saved you this paperwork. I found out the hospice is now full, hence there's no denying that a person wishing it was over is now blocking a bed! C'mon? Really?

I ask you to ratify voluntary assisted dying legislation as soon as possible and even to go further than just we, whom are terminally ill, but also those whom wish to succumb to an accidental permanent disability which does require 24 hour care. A young victim of an accident might not want to be where I am now... existing.

I hope this page resonates and inspires some to ease the suffering of others to come.
