Answer to Questions 1- 47:

Global written questions have been requested by the Member for Arnhem, Selena Uibo MLA, twice in the 2024-25 financial year; December 2024 and March 2025.

The estimated cost to government to respond to global written questions is \$417,600. In 2024-25, this equates to \$835,200 for the year.

Noting established practice, questions regarding agency structures are ordinarily raised once annually in advance of the Estimates process. It is anticipated that these matters will again be the subject of questioning prior to the 2026 Estimates period.

In this context, the repeated requests received during the 2024–25 financial year exceed usual practice, and further duplication at this time would not represent an efficient or appropriate use of public resources.
