Mr Wood (Member for Nelson) will move on the next meeting day that the government sets up a task force from Motorsport Northern Territory, and the departments responsible for Crown lands, the department responsible for sport and recreation, the police department, and any other departments that may have an interest, to look at establishing an off road park in the greater Darwin region so that the owners of ATVs and quad bikes can enjoy the use of their vehicles in a safe and accessible environment. The task force could also look at the facility for competition to attract both local and interstate riders. The possibility of a recreational licence for bikes should also be included in discussions.

Mr Wood (Member for Nelson) will move on the next meeting day that the definition of the RR (rural residential) zone as described in the Northern Territory planning scheme, state that the minimum lot size for the RR zone in the Litchfield municipality is 1ha. This was always the definition since that zone was established but only changed last year by the previous CLP Minister for Planning.

12. MOTION: ASSESSMENT OF THE NORTHERN TERRITORY ONSHORE GAS INDUSTRY

Mr Mills (Member for Blain), pursuant to notice, moved:

That this assembly calls upon the Northern Territory Government to conduct a comprehensive economic assessment of how a carefully managed onshore gas industry would affect the Northern Territory.

This assessment should include but not be restricted to an assessment of royalty scheme options for the Northern Territory and the effect on regional economic development including employment and training.

An assessment of the economic impact of onshore gas exploration on small to medium sized Northern Territory enterprises.

And consideration should also include an assessment of gas reservation policy options and a cost benefit analysis of gas reservation or otherwise on Northern Territory economic development.
