### SUBORDINATE LEGISLATION NO. 25 OF 2017

#### LIQUOR AMENDMENT REGULATIONS 2017

[UPDATING SCHEDULE 1 OF THE LIQUOR REGULATIONS]

#### **Purpose**

To amend the Liquor Regulations to update the list of licences that are not required to comply with section 31A(5) of the *Liquor Act*. Section 31A(5) of the *Liquor Act* provides that a holder of a relevant liquor licence is not authorised to sell liquor without scanning an approved form of identification. The relevant licences are prescribed under regulation 5A(1), however regulation 5A(2) provides for a schedule (Schedule 1) of licences to which section 31A(5) of the Act does not apply.

Following the reintroduction of the Banned Drinker Register, it has been necessary to review the licences listed in Schedule 1 and update those licences not required to scan identification prior to the sale of liquor.

#### **Summary of key provisions**

- Schedule 1 of the Liquor Regulations is replaced with an amended list of licences exempt from the requirement under section 31A(5) of the *Liquor Act* to scan identification prior to the sale of liquor.

#### **Legislative Authority**

Section 128(1) of the *Liquor Act*.
