4. MOTION: APPOINTMENT OF SELECT COMMITTEE OPENING PARLIAMENT TO THE PEOPLE AGREED TO

Ms Fyles (Leader of Government Business), pursuant to notice, moved:

- 1. That a Select Committee on the subject of Opening Parliament to the People be appointed comprising the Members for Fong Lim, Stuart, Sanderson, Karama, Daly, Nelson and Araluen.
- 2. The Committee is to inquire into options for parliamentary reform, particularly increased participation in the legislative process and policy debates and improving the effectiveness of Question Time, having regard to, among other things, the Parliamentary Reform Opening Parliament to the People (Labor Policy Discussion Paper) and Restoring Integrity to Government Trust and Integrity Reform Discussion Papers published by the then Opposition ahead of the Northern Territory Election and the Discussion Paper on Assembly Committee Reform tabled by the Speaker on 25 August 2015 and other proposals which the 12th Assembly Standing Orders Committee deferred for consideration of the 13th Assembly.
- 3. The Committee is to report to the Assembly by 31 March 2017.

- Recognises that the abuse of alcohol is at the centre of the most devastating social issues in our community including domestic violence; child neglect; violent crime and anti-social behaviour.

- Calls on the Territory Government:
 - To set politics aside and not discard current measures where they are having a positive impact; and
 - To work with the Parliament as a whole to develop real and lasting solutions to this entrenched social problem.
- Requests that the Territory Government reports to this Parliament every 6
 months regarding the effectiveness of alcohol abuse reduction measures
 including as a minimum with regard to:
 - Sale of Alcohol
 - Domestic Violence
 - Child Neglect
 - Violent Crime; and
 - Anti-social behaviour
