In 2012, the former Department of Housing, Local Government and Regional Services, procured the services of a local accounting firm which reviewed the financial sustainability of the Northern Territory's eight regional and three smaller shire councils and issued its key findings and recommendations in a report titled "Review of Councils' Financial Sustainability".

In 2013, as part of the review of Local Government, the Department of Local Government and Regions issued a Certificate of Exemption to engage the same accounting firm to review the key findings of its 2012 report and assess the progress that had been made in regards to implementation of the report's recommendations and to highlight any outstanding issues relating to regional council viability and sustainability.
