1. Would you please advise what grant, program, project and operational funding was provided by the former Department of Justice to non-government and external organisations in the year to 24 August 2012.

The Department of the Attorney-General and Justice has in place three service agreements to 30 June 2013 for the provision of 'Intervention and Case Management Services'. These are currently provided by the Larrakia Nation Aboriginal Corporation in Darwin, Mission Australia in Katherine, and Tangentyere Aboriginal Corporation in Alice Springs. Refer to the response for Question 2 for details.

Agreements with the three current providers to deliver the Integrated and Case Management Services will not be renegotiated following the completion of the current funding period (ie, 30 June 2013).

The mini-budget also provided for \$165,000 ongoing supplementation funding from 2012-13 for Domestic Violence Legal Services. These services are currently delivered under service agreements by the Northern Territory Legal Aid Commission in Darwin, and the Central Australian Women's Legal Service in Alice Springs. This supplementation funding was previously an unfunded liability, and as such does not impact on the existing payment schedule for the current domestic violence legal services funding agreements. The supplementation funding provided in the mini-budget will be included in the scope of the renegotiation of these services at the end of the current funding period (ie, 30 June 2013).

4. Would you please outline the specific changes, amendments and monetary adjustments to service or funding agreements between the Department of Attorney-General and Justice and non-governmental and external organisations referred to in question 3 above.

The three service agreements for the delivery of Integrated and Case Management Services will not be renegotiated following the completion of the current funding period (ie, 30 June 2013).

Would you please advise what grant, program, project and operational funding provided by the Department of Attorney-General and Justice to non-government and external organisations will be adjusted or diverted, and by how much, as the result of the implementation of measures contained in the Northern Territory mini-Budget on 4 December 2012
