- 2. The outcome of the above applications is to be found within attachments A to F attached.
- 3. Unsuccessful applications, if considered to be valid Special Education requests, are met as far as possible within existing resources.
- 4. The oncost component for the Commonwealth Special Education Program is 15.6% for each element of the program in 1991and 16.1% for each element of the program in 1992.
- 5. Note: Mr Bell has requested this information previously. (Refer Appropriation Bill 1991-1992, Supplementary and Other Questions Rationalisation of Services).

The Oncost Component consists of 2 elements -

(i) Secretariat Levy (1991 - 7.5%, 1992 - 8%)
Departmental Levy (1991 - 8.1%, 1992 - 8.1%)
```

For 1992 a levy was applied for Advisory services -

School Support - Government Grants - 2%. Intervention Support Joint Grants - 2%.

All administration and meeting costs are provided through the Commonwealth Programs Secretariat which is fully funded from levies applied to Commonwealth programs. The amount levied against the Commonwealth Special Education Program for this purpose was \$50 437 for 1991, \$52 320 for 1992.

(ii) Departmental Levy (1991 - 8%, 1992 - 8%)

This Levy was calculated through the identification of costs incurred by the department in providing indirect administrative support to the program such as payment of salaries to program staff, payment of accounts, coordination of projects by departmental officers and any other tasks which could not be economically transferred to the Commonwealth Programs Secretariat.

The department is reimbursed for the cost of providing these indirect administrative duties.

(iii) Advisory Levy (1992 - 2%)

This levy was calculated through the identification of salary and operational costs incurred for the 2 advisory officers. School Support Government Grants - 2%, Intervention Support Joint Grants - 2%.
