Engagement and Compliance Officers

1. How many Engagement Officers and how many Compliance Officers are there in the Northern Territory, and where are they located?

As of 2021, there is no distinction in title or function between Compliance Officers and Engagement Officers; all are now referred to as Student Engagement Advisors.

Table 1 shows that there are 44 Student Engagement Advisor positions located across the 6 regions of the Northern Territory (NT). Eight of these positions are currently vacant and subject to recruitment (indicated in brackets below).
