Most Northern Territory Government agencies have implemented special measures arrangements across the whole agency or for some roles. ## OUTSOURCING

#### **Community Housing Management Transfers**

- In December 2023, the Department of Territory Families, Housing and Communities (the Department) executed 20-year agreements (10+ 10 years) with 2 Community Housing Providers (CHPs) for the management transfer of 501 urban public housing dwellings. This included:
  - 251 dwellings in Darwin to Mission Australia Housing NT (MAH-NT); and
  - 250 dwellings in Palmerston to Venture Housing.
- The transfer with MAH-NT went live on 8 April 2024, and with Venture Housing will commence on 1 July 2024.
- From these dates, the CHPs become the landlord, taking on responsibility for asset and tenancy management services, in line with the Community Housing Asset and Tenancy Management Policy. The Department continues to own the dwellings and retains responsibility for structural repairs.
- (b) Is consideration being given to outsource, contract-out or privatise in financial year 2024/25? If so, provide details.

**Community Housing Management Transfers** 

- The Department is negotiating direct management transfers of 100 dwellings to each of Community Housing Central Australia (CHCA) and Yilli Housing.
- The Department is also planning to release an Expression of Interest for the management transfer of a further 300 dwellings in Greater Darwin in 2024/2025.

Due to the significant administrative effort required to provide a detailed breakdown of advertising and communications costs, the Department has provided a broad overview of its communications and marketing activities for the period.

The Department of Territory Families, Housing and Communities' total expenditure for advertising and communications for the period 1 July 2023 to 31 March 2024 was \$617,622 (compared to \$667,173 for 1 July 2022 to 31 March 2023).

This expenditure includes expenses such as:

- printing of collateral (for example posters, flyers and banners);
- event costs (for example, venue hire and merchandise);
- advertising fees (for example print, online and social media);
- development of video and animation materials (for example explaining processes and complex systems to community and stakeholders); and
- some administrative costs (such as subscriptions to media outlets and marketing software).

As a diverse frontline agency, the Department of Territory Families, Housing and Communities has wide-ranging requirements for advertising and communications. These can be broadly categorised as:

- promoting available grants to the sector and public;
- promoting available services, vouchers and concessions to the public; and
- communicating rights and responsibilities to our client base.

Marketing services are provided internally where possible, such as strategy and content development, graphic design and photography. All advertising is booked through the approved Northern Territory Government provider, Atomic 212.

The primary media channel for the Department's advertising spend is the NT News. Notable advertising campaigns for this period included the 'Pride in Your Place' public housing recognition campaign.

Notable marketing and communications activities for the period 1 July 2023 to 31 March 2024 included:

- 50th anniversary celebrations of the NT Sports Awards;
- sponsorship of a dedicated NT edition of Parity Magazine;
- design and development of dedicated community noticeboards to support communication with remote housing tenants in Central Australia about Housing Reference Groups, housing support and healthy homes;
- delivery of the Northern Territory Performing Arts Awards;
- development of animations to explain 360 degree View of the Child implementation to community;
- promoting the National Energy Bill Relief program to eligible concession holders;
- promoting what was on at the Araluen Arts Centre;
- participation in the NT show circuit;
- promotion of the NT Concession Scheme and the NT Seniors Recognition Scheme; and
- promotion of sport vouchers.
