Answer:

Leases over remote public housing are required to underpin investment in new housing under the Strategic Indigenous Housing and Infrastructure Program (SIHIP).

Sixteen communities have been allocated new housing. Leases pursuant to section 19 of the *Aboriginal Land Rights (Northern Territory) Act* (ALRA) have been secured in eight (8) of these communities. These leases are for a period of forty (40) years. A further six (6) subleases have been secured in communities where the Executive Director Township Leasing (EDTL) holds the head lease through either a section 19 or 19A lease. The term of the subleases vary from 40 to 10 (10) years. Negotiations in the remaining two (2) communities are ongoing.

Short term leases over the remote public housing lots have also been secured in 2 communities that are not subject to the Australian Government five (5) year leases; with negotiations underway in two other communities. These short term leases are required to underpin the investment in housing.

The Northern Territory Government also holds leases over the Tennant Creek and Alice Springs town camps and negotiations are in progress for the town camps at Borroloola. Leases are also held over two small outstations in the Victoria Daly Shire region; these leases were assigned to the Territory under arrangement with the Australian Government.

All leases for remote public housing are on a 'peppercorn' rent basis.

Negotiations for leases of land occupied by Northern Territory Government infrastructure in Growth Towns on Aboriginal Land are well advanced. The Land Councils have undertaken consultations in most locations and the Traditional Owners have agreed in principle to leases.

Negotiations for leases to underpin construction of new infrastructure projects are also underway; these leases cover a range of infrastructure in a number of communities across the Territory. The rollout of this infrastructure is dependent on leases being secured.

No leases for government infrastructure have been executed at this date. The lease payment options are currently subject to consideration by Government.
