

- d) Royal Darwin Hospital Intersection Upgrade

The Department of Infrastructure, Planning and Logistics (DIPL) engaged True North Strategic Communication to complete a door knock of properties on Rocklands Drive from Henbury Avenue to Manbulloo Street and a letterbox drop to the wider suburb of Tiwi. True North led a door knock to gather sentiment and feedback on 15 February 2024, followed by a letterbox drop the following day, 16 February 2024.



#### Results

On 15 February 2024, True North completed a door knock for properties on Rocklands drive, between Henbury Avenue to Manbulloo Street development project.

- True North attempted a door knock on 20 properties
- there was a response from six properties where residents were home to accept the fact sheet and were available to give feedback
- four out of the six properties consulted had a positive sentiment towards the suggested upgrade
- one out of the six properties consulted had a negative sentiment towards the suggested upgrade

- one out of the six properties consulted had positive sentiment on the line works of the proposal and negative sentiment on the proposed parking spaces
- stakeholder notices were dropped off to approximately 400 neighbouring properties
- letterbox drop for the Tiwi area and surrounding businesses was completed on 16 February 2024.
