Question

What is the timeline for construction of the revoted capital works regarding upgrades to cyclone shelter in the northern suburbs?

Answer

It is noted that, on 21 May 2014, as part of 2014-15 infrastructure program finalisation, the Treasurer approved a new project, at \$0.619 million, on the Department of Infrastructure's (DoI) 2013-14 Capital Works Program for a cyclone shelter in the northern suburbs, fully funded by substitution from DoI's 2013-14 CWP cyclone shelter upgrades project.

An indicative timeline for project completion follows:

- Approx. 1 month to conduct stakeholder consultation
- Approx. 3 months to complete design, scope, RFT documentation, response schedules etc.;
- Approx. 3 months to complete the procurement processes leading to the award of contract;
- Approx. 4 months to complete the build.

Feasibly the preparatory (pre-build) processes could be finalised by Dec 2014 with works to commence in Jan/Feb 2014.

It is noted that original cost estimates undertaken by this Department did not include any assessment of the structure's original functionality as a hall, only whether it could be upgraded to the standard of designated public cyclone shelter. As such, the potential additional costs which may be incurred upon the building's upgrade (e.g. the costs

associated with installation of air-conditioning units or large fan units adequate for an enclosed area of this size) have not been considered in any costing.

Without allowing unforeseen impediments such as access limitations placed on works by the Building owner, it is anticipated that the project could be completed before the end of the 2014-15 FY.
