# 15. CHILD PROTECTION FUNDING LEVELS – MOTION AS AMENDED, AGREED TO:

The Member for Nightcliff (Ms Fyles), pursuant to notice, moved - That, the House call on the Government to commit to the full implementation of the Board of Inquiry recommendations into Child Protection, and furthermore that the Government guarantee that they commit to maintaining to the same level of funding for the Office of Children and Families with the Department of Education and Children Services. Debate ensued.

The Minister for Children and Families (Mrs Lambley) moved the following amendment to the motion - Omit all words after "That" and insert the following words -

#### "the House:

- supports the Board of Inquiry recommendations into child protection;
- notes its appreciation for the Board of Inquiry's attempt to address the very real and significant issues in child protection in the Northern Territory through its recommendations;
- calls on Government to commit to improving service delivery from the Office of Children and Families within the Department of Education and Children's Services; and
- calls on the Minister to provide a Ministerial Statement on the implementation
  of the recommendations of the Board of Inquiry's Report to the House, at the
  next Sittings.".
