- There are also 129 current "Continuing Special Liquor Licences" within the entire NT. These licences are generally issued to not-for-profit social and sporting clubs for a maximum trading of 30 hours per week, whereby members can purchase and drink liquor on the premises. No take away is permitted. All liquor purchased by these licence holders must be purchased from a retail store.
