Homebuild NT

1. What contracts have been awarded to construct new public houses under this program? Please list by date awarded, contractor, location, and progress (e.g. completed, under construction etc)

HomeBuild NT officially commenced on 1 July 2017.

Since 1 July 2017, 266 houses have been constructed across all programs in remote communities.

The allocation of homes is usually within six weeks of completion. There are instances when this may vary due to unforeseen cultural activities occurring in the community.

Business as usual repairs and maintenance on government employee homes in remote communities is in place.

Although \$200 million is allocated across 10 years, \$10 million was allocated per year for the first two years of the program recognising planning, land availability and land tenure requirements necessary for construction.

Government Employee Housing allocation for the 2017-18 and 2018-19 financial years totals \$20 million. Government Employee Housing expenditure to 28 February 2019 totals \$4.1 million, with a current commitment of \$5 million.
