- 2. CONDOLENCE THE HON. F.J.S. WISE, A.O.: Mr Hatton (Chief Minister), by leave, moved - That this Assembly expresses its regret at the death of the Honourable Frank Joseph Scott Wise, A.O., Administrator of the Northern Territory from 1 July 1951 to 30 June 1956 and former Premier of Western Australia; places on record its appreciation of his distinguished service to the people of the Northern Territory; and tenders its profound sympathy to his widow and family.

Debate ensued.

3. IMPENDING RESIGNATION, LEADER OF THE OPPOSITION - STATEMENT - MOTION TO NOTE STATEMENT: Mr B. Collins (Leader of the Opposition), by leave, made a statement relating to his impending resignation as Leader of the Opposition. Mr Hanrahan (Leader of Government Business) moved - That the Assembly take note of the statement.

Ordered - That Mr Hanrahan have leave to continue his remarks and the resumption of the debate be made an order of the day for a later hour.

4. SEVENTY-FIFTH ANNIVERSARY MESSAGE FROM COMMONWEALTH PARLIAMENTARY ASSOCIATION:

- (b) by omitting subsection (3)".

Question - That all words proposed to be omitted, be omitted, agreed to. Mr Ede moved the following amendment to the amendment -

That the amendment moved by the Honourable Minister for Mines and Energy be amended by omitting all words after "is amended" in the words proposed to be inserted and inserting in their stead "by omitting '\$100 000' (wherever occurring) and substituting '\$250 000'.".

Amendment to the amendment negatived, after debate. Question - That the words proposed to be inserted by Mr Coulter's amendment, be inserted, agreed to. Bill as amended, agreed to.

The Assembly resumed - the Chairman (Mr Finch) reported accordingly and the report was adopted.

- 1. The Assembly met at 10.00 a.m., pursuant to adjournment. Mr Speaker (the Honourable R.W.S. Vale) took the Chair, and read prayers.
- QUESTIONS: Ouestions were asked of Ministers.
- 3. DISCUSSION OF MATTER OF PUBLIC IMPORTANCE:

 Mr Speaker informed the Assembly that Mr Ede (Deputy Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the Assembly for discussion, namely "the very high rate of unemployment amongst Aboriginal communities in the Northern Territory.".

- (b) because of this variation in duties, there needs to be a more flexible system of determining the salaries of electorate secretaries;

- (c) because the nature of the duties of electorate secretaries can require them to use their personal vehicles for official purposes, mileage allowances should be payable up to a maximum amount depending upon the demands imposed by the geographical and other characteristics of a particular electorate; and
- (d) because the employment is essentially of a contractual nature, it is not appropriate that certain allowances payable to permanent public servants should be paid.

Question - put and passed.

Question - put and negatived.

Ouestion - put and passed.

7. REDEVELOPMENT OF OLD POLICE HEADQUARTERS SITE, DARWIN - MINISTERIAL STATEMENT - STATEMENT NOTED:

Mr Hanrahan (Minister for Business, Technology and Communications), by leave, made a statement relating to the redevelopment of the old Police Headquarters Site in Mitchell Street together with the inclusion of facilities for an interim Parliament House.

Mr Hanrahan moved - That the Assembly take note of the statement.

 - "(2A) The Committee act for and represent the Legislative Assembly in all matters concerned with the planning, design and construction of any interim accommodation proposed for the Legislative Assembly, its Committees, Members and officers and all matters incidental thereto";
 - (b) by inserting in paragraph (4) after the word "thereto", the words "or any matter relating to the planning, design and construction of interim accommodation proposed for the

Legislative Assembly, its Committees, Members and Officers"; and

(c) by omitting from paragraph (4)(a) the words "the Minister for Transport and Works" and inserting in their stead the words "the relevant Minister".

Question - put and passed.

Insert after subclause (2) the following:

"(2A) For the purposes of subsection (2), a person is deemed to have obtained the approval required if the food vending machine intended to be installed is of a brand, class or kind that the Chief Medical Officer has, by notice in the Gazette, declared that a person may instal without first obtaining the Chief Medical Officer's specific approval in writing.".

Clause, as amended, agreed to.
Clauses 14 to 56, by leave, taken together and agreed to.
Clause 57 On the motion of Mr Harris the following amendment was made -

Insert after subclause (4) the following:

"(5) The requirement in section 13(3) relating to the registration of certain food vending machines shall not apply to a person servicing, selling or permitting the sale of food by means of a food vending machine as at the commencement of this Act until the expiry of the period of 6 months after that commencement.".

Clause, as amended, agreed to.
Remainder of the Bill, by leave, taken as a whole and agreed to.
Bill to be reported with amendments.

The Assembly resumed - the Deputy Chairman (Mr Perron) reported accordingly and the report was adopted.
