## Tuesday 18 March 1986

- 1. The Assembly met at 10.00 a.m., pursuant to resolution. Mr Speaker (the Honourable R.M. Steele) took the Chair, and read prayers.
- 2. CONDOLENCE MR J.L.S. MacFARLANE C.M.G.: Mr Tuxworth (Chief Minister), by leave, moved - That this Assembly expresses its deep regret at the death of John Leslie Stuart MacFarlane CMG, an elected member for the Division of Elsey in the Northern Territory of the Legislative Council from 26 October 1968 and the Legislative Assembly from 19 October 1974 and Speaker of the Legislative Assembly from 12 August 1975 until 2 December 1983; places on record its appreciation of his long and meritorious service to the Legislative Council, the Legislative Assembly and the people of the Northern Territory; and tenders its profound sympathy to his widow and family.

Debate ensued.

And Members present having stood in their places in silence - Question passed.

**Suspension of sitting:** As a mark of respect to the former member and Speaker of the Legislative Assembly, the sitting was suspended between 11.23 a.m. and 2.00 p.m.

3. HON. J.M. ROBERTSON - IMPENDING RETIREMENT - STATEMENT - MOTION TO NOTE STATEMENT:

Mr Robertson (Special Minister for Constitutional Development), by leave, made a statement relating to his impending retirement as a member of the Legislative Assembly, on 26 March 1986.

Mr B. Collins (leader of the Opposition) moved - That the Assembly take note of the statement.

Ordered - That the debate be adjourned and that Mr B. Collins have leave to continue his remarks on the resumption of the debate.

 COMMONWEALTH DAY - MESSAGE FROM COMMONWEALTH PARLIAMENTARY ASSOCIATION -PAPER TABLED:

Mr Speaker laid on the Table the following message from the Honourable Bal Ram Jakhar, Chairman of the Commonwealth Parliamentary Association relating to Commonwealth Day, 10 March 1986:

'Though scattered over six continents, the members of the Commonwealth think in unison on many matters of common concern to humanity at large. Today, on Commonwealth Day, we take pride in belonging to a community where familiarity and friendship, cooperation and consultation are watchwords. It is the day for affirming our resolve to further strengthen the bonds that have held us together.

The Commonwealth has been the most successful example of international cooperation. It has served as a bridge between races and cultures, countries and continents, and has provided a sense of belonging among its members. In time of crisis a member finds some emotional security in not being alone. He is aware that an organization of friends is behind him to lend a helping hand. The Commonwealth has tried to provide a healing touch whenever a crisis situation has developed in any part of the Commonwealth. It is a body bereft of any military force, but, by its moral authority, it restrains the nations from straying into wrong paths. Its appeals have a significant bearing on world opinion and international relations.

The Commonwealth has engaged itself constructively in various fields and tried to better the lot of the deprived mass of humanity through a number of programmes and a network of institutions and organizations working on the philosophy of mutual cooperation and consultation.

The Commonwealth Parliamentary Association is an organization of Legislators. Here they are engaged in a joint search for solutions to the problems of distrust, conflict and the arms race, as well as to the eradication of poverty, ignorance and disease. Here their hearts pulsate with the one thought of bettering our world. Brought together by history, they are devoted to the common ideals of peace, democracy and respect for the dignity of man. The CPA serves as an instrument to strengthen these ideals.

On this Commonwealth Day, therefore, let us each make a promise that we shall continue to do our utmost to create a society which is just and equitable, and that we shall stand by the people who are still oppressed by poverty, racial discrimination and colonial domination.

Bill to be reported with an amendment.

1. The Assembly met at 10.00 a.m., pursuant to adjournment. Mr Speaker (the Honourable R.M. Steele) took the Chair, and read prayers.

## 2. NOTICE:

The following notice was given:

Mr Ede: To present the Aboriginal Sacred Sites Amendment Bill 1986 (Serial 156).

### 3. OUESTIONS:

Questions were asked of Ministers.

Privilege - Request for referral of matter to Committee of Privileges - Paper Tabled:

Mr B. Collins (Leader of the Opposition), pursuant to Standing Order 83, raised as a matter of privilege an answer given by the Minister for Primary Production (Mr Hatton), claiming that he had deliberately misled the Assembly, and requested that the Speaker refer the matter to the Committee of Privileges.

- COMMISSION OF INQUIRY (CHAMBERLAIN CONVICTIONS) BILL 1986 (Serial 172): Mr Perron (Attorney-General), pursuant to notice, presented a Bill for an Act to provide for a Commission of Inquiry in relation to certain criminal convictions.

Bill read a first time.

Mr Perron moved - That the Bill be now read a second time.

Debate adjourned (Mr B. Collins) and the resumption of the debate made an order of the day for a later hour.

7. DISCUSSION OF MATTER OF PUBLIC IMPORTANCE - BUILDERS' LICENSING:
Mr Speaker informed the Assembly that Mr Bell (Member for MacDonnell) had
proposed that a definite matter of public importance be submitted to the

Banking Group to the Chief Minister, 19 March 1986.

Omit subclauses (2) and (3) and insert in their stead the following:

- "(2) Subject to subsection (3), the Minister shall, in writing, appoint 3 persons to be members of the Board from a list of not less than 6 dentists submitted to him by the Australian Dental Association (Northern Territory Branch) within 28 days after he requests such a list to be submitted.
- "(3) Where the Minister has requested a list referred to in subsection (2) to be submitted but no list or, in his opinion, an insufficient list, is submitted to him before the expiration of 28 days after the request, he may appoint any 3 dentists, as he thinks fit, to be members of the Board.".

Clause, as amended, agreed to.

Clause 6 agreed to.

Clause 7 -

On the motion of Mr Hanrahan the following amendment was made -

Omit from subclause (1) all words after "one of their number" and insert in their stead "to be the Deputy Chairman of the Board and the office of Deputy Chairman shall become vacant immediately before each election.".

Clause, as amended, agreed to.

Clauses 8 to 17, by leave, taken together and agreed to.

Clause 18 -

On the motion of Mr Hanrahan the following amendment was made -

Omit from subclause (1) paragraph (d) and insert in its stead the following:

Clause, as amended, agreed to.

Clause 19 -

On the motion of Mr Hanrahan the following amendment was made -

Insert in subclause (2) after "without restriction" the word "until".

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole and agreed to.

Bill to be reported with amendments.

The Assembly resumed - the Deputy Chairman (Mr Vale) reported accordingly and the report was adopted.

On the motion of Mr Hanrahan (Minister for Health) the Bill was read a third time and passed to be a proposed law.

Clause, as amended, agreed to. Remainder of Bill, by leave, taken as a whole and agreed to. Bill to be reported with amendments.

The Assembly resumed - the Chairman (Mr Vale) reported accordingly and the report was adopted.

On the motion of Mr Coulter (Minister for Community Development) the Bill was read a third time and passed to be a proposed law.

## Thursday 20 March 1986

 The Assembly met at 10.00 a.m., pursuant to adjournment. Mr Speaker (the Honourable R.M. Steele) took the Chair, and read prayers.

 PRIVILEGE - ANSWER TO QUESTION BY MINISTER FOR PRIMARY PRODUCTION -REQUEST FOR REFERRAL TO COMMITTEE OR PRIVILEGES - SPEAKER'S DECISION -STATEMENTS:

Mr Speaker advised the Assembly that he had considered the request of Mr B. Collins (Leader of the Opposition) to refer a matter to the Committee of Privileges:

Mr Speaker informed the Assembly of his decision in the following terms -

"I have examined the documents tabled by Mr Collins and have taken note of his statement. I have also noted the rebuttal made by the Honourable Minister in his Personal Explanation following Question Time and have considered the letter tabled later by the Minister from Mr A.B. Cowan, Group Account Executive of Westpac, in which Mr Cowan states that the recording of events by Mr Moore is inaccurate to the extent that he had never been contacted by Mr Hatton and in fact was contacted by Dr Richard Madden on the matter.

Mr Cowan further states that at the time of receipt, he manually corrected the copy of the memo sent to him by Mr Moore.

With these facts in mind, I do not propose to refer Mr Collins' complaint to the Committee.".

Mr B. Collins (Leader of the Opposition), Mr Hatton (Minister for Primary Production) and Mr Tuxworth (Chief Minister), by leave, made statements relating thereto.

### 3. OUESTIONS:

Questions were asked of Ministers.

Privilege - Request for referral to Committee of Privileges:

Mr Robertson (Leader of Government Business), pursuant to Standing Order 83, raised as a matter of privilege the Memoranda tabled by Mr B. Collins requesting that Mr Speaker refer the following matters to the Committee of Privileges to examine:

- (1) whether or not the documents tabled yesterday by the Leader of the Opposition in question time were the property of the Federal Court of Australia or a judge thereof; and if so did those documents have attached to them confidentiality in the right of the Federal Government of Australia or a judge thereof, or confidentiality in the right of other parties as a result of their being the property of the Federal Court of Australia or a judge thereof; and
- (2) if the answer to either point in question (1) is yes, did the public disclosure of the contents of those documents by the Leader of the Opposition in question time yesterday constitute a breach of privilege of the Legislative Assembly by the Leader of the Opposition?

Mr Speaker agreed to consider the matter and report his decision before or during the next day of sitting.

- 4. CENSURE OF CHIEF MINISTER MOTION NEGATIVED: Mr B. Collins (Leader of the Opposition), by leave, moved - That this Assembly censures the Chief Minister of the Northern Territory because -
  - (1) the Chief Minister did knowingly receive amounts of public money by way of tax free travelling allowances to which he was not entitled;
  - (2) the Chief Minister's action in so doing was tantamount to fraudulent behaviour and would have resulted in dismissal and the institution of criminal proceedings had he been a Public Servant; and

this Assembly calls upon the Chief Minister to resign forthwith.

Debate ensued.

Extension of time: On the motion of Mr Smith (Millner)
Mr B. Collins was granted an extension of time.
Debate continued.

Suspension of sitting: The sitting was suspended between  $11.47 \ \text{a.m.}$  and  $2.00 \ \text{p.m.}$ 

Debate resumed.

Motion without notice - Leave to move not granted:

And Mr B. Collins, speaking in reply - asked leave to continue his remarks.

Objection being raised, leave not granted.

Extension of time: On the motion of Mr Leo (Nhulumbuy) an extension of time was granted to Mr B. Collins.

7. PRIVILEGE - REQUEST FOR REFERRAL TO COMMITTEE OF PRIVILEGES - PAPER TABLED:

Mr B. Collins (Leader of the Opposition), pursuant to Standing Order 83, raised as a matter of privilege a letter he received from Mr P.J.
