Tuesday 4 June 1985

- 1. The Assembly met at 10.00 a.m., pursuant to resolution. Mr Speaker (the Honourable R.M. Steele) took the Chair, and read prayers.
- 2. MESSAGE FROM THE ADMINISTRATOR:
  - Mr Speaker read the following message from His Honour the Administrator:

Message No. 2 I, ERIC EUGENE JOHNSTON, the Administrator of the Northern Territory of Australia, in pursuance of section 11 of the Northern Territory (Self-Government) Act 1978 of the Commonwealth, recommend to the Legislative Assembly a Bill for an Act to make interim provision for the appropriation of moneys out of the Consolidated Fund for the service of the year ending 30 June 1986.
