## Response

Crown land is sold under the provisions of the *Crown Lands Act* and in line with relevant Government policies.

Crown land that is identified for strategic release to support the economic growth of the Northern Territory through the delivery of new residential and industrial estates is released via a public competitive process.

Crown land is also released through Direct Sales and Community Land Grants which are application based processes. These are for the purposes of supporting community initiatives (community land grant scheme) as well as commercial development (direct sale). Details of Direct Sales are provided here, for details of Community Land Grants please refer to Tranche 4/Folio179/WQ2.

**Market Value** – where land is sold through a public competitive process like an auction or through expressions of interest, the sale price is considered to represent *market value*. Where land is sold through the Direct Sale process an independent valuation of the land is sought prior to sale and those valuations are recorded here as *market value*.
