# 9. MOTION: GOVERNMENT SUBMISSION TO THE PRODUCTIVITY COMMISSION INQUIRY NOT AGREED TO

  - (c) who composed the draft and final submissions,
  - (d) who authorised a draft submission made public on 13 July 2017, and
  - (e) whether a draft was submitted prior to the final.
- 2. The Committee will hold its hearings for this inquiry in public unless the Committee agrees to a request from the witness to go into private session to deal with a matter of a confidential nature.
- 3. The Assembly requires any Ministers who the Committee asks to appear before it to answer questions to do so.

# 10. MOTION: NT HORTICULTURE AND HOSPITALITY INDUSTRIES

This Assembly calls upon the Northern Territory Government to recognise the importance of the NT horticulture and hospitality industries and their contribution as important economic growth drivers in the north,

and to work with the local horticulture and hospitality sector and other stakeholders; including the Commonwealth Government to develop new models to address a labour shortfall at these critical times by developing improved models to access these labour markets of ASEAN.

This Assembly calls upon the Northern Territory Government to recognise the importance of the NT horticulture and hospitality industries and their contribution as important economic growth drivers in the north,

to, as a continuing priority, work with the local horticulture and hospitality sectors and other stakeholders; including the commonwealth government to address labour shortfalls in the first instance, developing strategies to employ Territorians in jobs that are available in these industries and in the second instance, developing strategies to attract staff from outside of the Territory where Territorians are not able to fill available jobs.
