Damage to Sacred Sites 2009-2010

The Aboriginal Areas Protection Authority 2009-10 Annual Report referred to responses to 10 new reports of sacred site damage. A subsequent review of data has shown that there were 12 sacred site damage reports in 2009-2010. These site damage reports are as follows:

- Tanami Road Alleged damage to a sacred bloodwood tree at Witchetty Bore.
 Following consultations with custodians and advice from the Department of Construction and Infrastructure (DCI), the matter has been resolved by an agreement between custodians and the DCI.
- Plenty Highway Alleged damage to a sacred site at Manners Creek Station. A
 deep trench has been dug into the dry waterhole and several large old coolibah
 trees have been knocked over. The AAPA has contacted the landowners and
 Department of Construction and Infrastructure, but has not been able to gain
 evidence of involvement in the alleged damage.
- Banka Banka A fence has allegedly been constructed over a hill comprising a sacred site on Banka Banka Station. Legal advice from the Department of Justice indicated that there was insufficient evidence to proceed to prosecution. Discussion is continuing between the landowner, custodians and AAPA about restoration of the site and future management.

- **Helen Springs** Graffiti on boulders comprising two sacred sites in the Stuart Highway road reserve. With insufficient evidence to identify possible offenders, the AAPA has negotiated with the DCI for the graffiti to be removed, under custodian supervision.
- **Beswick** The AAPA is currently investigating a recent report of works disturbing two grave sites and a ceremony area within the Beswick community. Cautionary letters seeking explanation have been sent to Roper Gulf Shire.
- Barrow Creek Alleged damage to a tree comprising a sacred site located on land adjacent to the Barrow Creek Hotel. Custodians have requested the hotel owners be notified regarding the site and its location.
- Kalanjarri A complaint was received about water extraction at a sacred site, a
 waterhole on Bonney Creek, within Aboriginal Land. AAPA's enquiries have
 identified sufficient information to seek a legal opinion from the Department of
 Justice.
- **Milingimbi** Alleged crabbing within a sacred site near Milingimbi. The Northern Land Council (NLC) have resolved the matter using the land use agreement between the crabbers and the traditional owners, and the AAPA has sent a caution letter to the crabber and the licensee, in Vietnamese.
- **Milingimbi and Glyde River (2)** Reports received from the Wanga Djakamirr Rangers of illegal fishing inside sacred site boundaries. Discussions have been held with the fishermen involved, and training has been provided to the ranger group with regard to evidence collection procedures.
- Ngalpa Ngalpa Camp, Tennant Creek During the course of SIHIP related works, a track was graded through a restricted work area (under an Authority Certificate) associated with a men's ceremony area within Ngalpa Ngalpa (Mulga) town camp. At the custodians' request AAPA revisited the area to ensure that all sites are adequately protected and a new Authority Certificate was issued over the camp. Custodians have requested that the matter be resolved through appropriate legacy infrastructure provision in support of men's ceremonies in that part of Tennant Creek. AAPA continues to negotiate this approach with the relevant agency.
- **Ludawei, Windows on the Wetlands** Alleged damage to the sacred site during works in the area. The issuing of an Authority Certificate protecting the site and allowing works has resolved the issue to the custodians' satisfaction.

Prosecutions 2009-10

Two prosecutions were successfully undertaken in 2009-10, in cooperation with Fisheries Police. A private barrister provided legal advice and acted for the Authority. Total legal costs for the Authority in 2009-2010 were \$3200.
