Review of the Northern Territory Government DriveSafe NT Program - Survey

As part a Review of the Northern Territory Government DriveSafe NT Program a survey was undertaken which invited 30 key stakeholders from remote settings and 30 from urban settings all involved in DriveSafe NT. Invitations to complete the survey were sent in early August 2019 to key stakeholders – DIPL (internal), other NTG Departments, local government, Community Development Program (CDP) providers, non-government organisations and third party service providers (namely driving schools).

CARRS-Q, the consultant for the review, developed the survey (using KeySurvey) for on-line access via a web address, provided to the Department project manager. An introductory page provided ethics-approved information and consent details, with acceptance required to proceed to the survey. Proceeding to the survey was considered to be informed consent.

The survey comprised three modules, as follows:

1. Roles of the respondent: involved with DriveSafe NT Urban and/or DriveSafe NT Remote and multiple specific role options, 'Deliver theory content sessions', 'Deliver practical driving lessons', 'Deliver practical assessments', 'Organise participant involvement in partnership with DriveSafe NT staff' and/or 'Other (please specify)'.
2. DriveSafe NT program modules (Your Driver Licence; Road Safety; Safe Driving; Road Rules; Penalties): ratings on perceptions of how well the content ('Doesn't work that well', 'About right', 'Works well') and time allocated ('Needs less time', 'About right', 'Needs more time') for each module was working in general, as well as overall ranking (1-5, with 1 being best); ratings and ranking of three that 'Work best' and three that 'Work least well' of the more specific topics and features within the modules; ratings on how well the program covers the NT Towards Zero priorities ('Not covered well', 'About right', 'Covered well'); and open questions for further feedback on

Planning Reform – Progressing Planning Reform

- An election commitment of this Government is to restore integrity, with a key component to undertake a reform of the Northern Territory Planning System by adopting the six planning principles outlined in the Independent Commission Against Corruption's (ICAC) 2012

Report into Anti-corruption safeguards and the NSW planning system. These six principles are:

- Providing Certainty – re-emphasise strategic planning, clear criteria to guide decisions and consistent decision making framework.
- Balancing Competing Interests – planning system to recognise spectrum of competing public interests including environmental, social and economic outcomes.
- Ensuring Transparency – improve transparency and provide meaningful, easy to access information about planning decision making processes and the basis for decisions.
- Reducing Complexity – create a straight forward regulatory structure that has reduced opportunity for error.
- Incorporating Meaningful Community Participation and Consultation – foster meaningful community participation and consultation and ensure adequate weight is given to submissions.
- Expanding Opportunities for Decisions to be Reviewed – provide third party appeal rights as a disincentive for corrupt decision making.

b) & c) Not applicable. A panel of members to undertake this review has not been appointed.

d) In 2019-20, \$71 038.67 has been spent on the review to 31 March 2020.

e)

A further \$63 936 was spent as a result of the Stage 4 consultation undertaken 6 March to 24 April 2020 in relation to the NT Planning Scheme 2020. \$51 939 is anticipated to be spent (2020-21) on a further stage of consultation to educate stakeholders about changes. This expenditure has been incurred through the engagement of Elton Consulting, who has been assisting with community engagement on the reforms.

f) Four rounds of consultation on Planning Reform have been completed to 30 July 2020. The previous rounds of consultation occurred during late 2017 and mid-2018. Stage three consultation occurred between 7 October and 29 November 2019, and Stage four consultation occurred from 6 March to 24 April 2020. The final round commenced 1 September 2020 and is anticipated to be completed 30 October 2020.

On 7 October 2019, the NT Government released a Consultation Draft Bill for Amendments to the *Planning Act 1999*, and Draft Examples of Possible Changes to the NT Planning Scheme (stage three consultation). Two supporting documents were also released to

provide context about how changes to the Act and planning scheme will work.

This consultation targeted frequent users of the planning system and those who had participated in previous consultation to the reform process. The consultation process was managed by Elton Consulting and included:

- A feature on the 'Have Your Say' website providing information and seeking feedback; and
- Information sessions and workshops held in Darwin, Alice Springs and Katherine for stakeholders including:
 - Community members
 - Environmental groups
 - Planning and legal professionals
 - Industry associations
 - Local government (LGANT, greater Darwin Councils, Regional Councils and Remote Councils in and around Katherine and Alice Springs)
 - Northern Territory Planning Commission.

During stage three consultation, 65 written submissions were received, and 129 people attended 19 information sessions and/or workshops.

On 6 March 2020, the Minister for Infrastructure, Planning and Logistics commenced statutory exhibition of the draft Northern Territory Planning Scheme 2020. The NT Government also commenced consultation on the draft *Planning Amendment Regulations 2020*. This is known as stage four consultation.

The above activities were replicated during stage four consultation, with 39 written submissions received, 9 surveys completed, and approximately 150 people attending 15 briefings and/or workshops (noting the majority of these were held online due to COVID-19 restrictions).

In addition, the draft Northern Territory Planning Scheme 2020 was also available from the Development Applications Online website in accordance with statutory requirements. This final stage of Phase 1 consultation concluded on 24 April 2020.

- g) The outcomes of the consultation informed the next stage of the planning reform process with the final stage informing the Minister's decision to introduce the NT Planning Scheme 2020 on 31 July 2020.
- h) Anticipated completion of the final education consultation is November 2020.

WORKPLACE HEALTH AND SAFETY

A total of 98 incidents were reported for the period 1 July 2019 to 30 June 2020.

There was one notifiable incident which relates to a Transit Safety Officer being assaulted while undertaking duties. This incident was reported to the Regulator due to the employee losing consciousness as a result of the assault.

Table 1 below indicates the nature of the incidents, whether first aid or medical treatment was required and the instances of lost time. There were zero fatalities reported.

Total costs of claims for the period was \$671,212.74.
