## Territory Insurance Office (TIO) Sale Allocation and Expenditure

1. In 2014 the Territory Insurance Office (TIO) was sold for \$424m. I request a breakdown of the exact allocation and expenditure of the \$424m as of 1 October 2015.

The final proceeds the Territory received for the sale of the Territory Insurance Office (TIO) was \$410.9 million.

The TIO sale has provided the Territory an opportunity for further economic and social development, with almost half the TIO sale proceeds being immediately re-invested in the Government's Building the Territory initiative.

This initiative was incorporated into the 2015-16 Budget and will see \$202 million of social, community and economic infrastructure projects, including flood mitigation works, progressed through the 2015-16 Capital Works Program.

Projects were identified through the Government's invitation to the public to propose infrastructure projects to be funded through the TIO sale proceeds.

Attachment A details the approved capital projects to be funded through the TIO sale proceeds, summarised by category, as well as the year to date expenditure and status of each project.

The balance of the proceeds will be invested in the recently announced Northern Territory Infrastructure Development Fund (NTIDF), to progress future strategic economic projects.

The NTIDF aims to attract up to \$1 billion of investment, including external investment from Australian superannuation funds, and other Australian and international institutional investors.

The key objective of the NTIDF is to be a long-term investor in a diversified portfolio of infrastructure assets that will:

- generate attractive risk-adjusted returns for all investors; and
- support the long term economic growth and development of the Northern Territory by investing in appropriate infrastructure projects.
