Within six months of the report being tabled, the Minister(s) must report to the Assembly what action, if any, the Government proposes to take in relation to each recommendation of the committee. Clause (5) then provides that the Speaker is to provide a report to the Assembly twice each year on the status of Government responses to committee reports.
