- MEETING: The Assembly met at 10.00 a.m., pursuant to adjournment. The Speaker, the Honcurable R.W.S. Vale, took the Chair.
- 2. PRAYERS.
- 3. MESSAGE FROM THE ADMINISTPATOR: The Speaker advised Members that he had received the following message from the Acting Administrator:

Message No.7

I, KEITH JOHN AUSTIN ASCHE, the Acting Administrator of the Northern Territory of Australia, in pursuance of section 11 of the Northern Territory (Self-Government) Act 1978 of the Commonwealth, recommend to the Legislative Assembly a Bill for an Act to appropriate certain sums out of the Consolidated Fund for the service of the year ending 30 June 1989.

4. NEW PARLIAMENT HOUSE, CANBERRA, FIRST SITTINGS - STATEMENT:

The Speaker advised Members that he had received an invitation to attend the first sitting of the Commonwealth Parliament in the New Parliament House, Canberra on Monday, 22 August 1988. He advised that due to sittings of the Assembly, the Deputy Speaker (Mr Dondas) would attend in his stead accompanied by the Deputy Clerk, Mr Ian McNeill. On the motion of the Leader of the Opposition (Mr Smith) debate was adjourned. Suspension of sitting: The sitting was suspended between 11.52 a.m. and 2.00 p.m. 8. SUSPENDED MEMBER - RE-ADMISSION TO HOUSE AND REVOCATION OF SUSPENSION: The Member for Stuart (Mr Ede), by indulgence of the Speaker and with the concurrence of Honourable Members, returned to the Chamber and referred to the incident on 16 August 1988 which resulted in his suspension from the Assembly. Mr Ede apologized and expressed his regret stating that he had not intentionally ignored the Speaker's call to order and would have complied immediately had he been aware of the call. With the concurrence of Honourable Members, the suspension of Mr Ede was revoked. 9. INTERPRETATION AMENDMENT BILL (No.3) 1988 (Serial 126): The Attorney-General (Mr Manzie), pursuant to notice, presented a Bill for an Act to amend the Interpretation Act.

Bill read a first time. Mr Manzie moved - That the Bill be now read a second time.

On the motion of the Member for Macdonnell (Mr Bell) debate was adjourned.

10. NATURAL DEATH BILL 1988 (Serial 113): The Attorney-General (Mr Manzie), pursuant to notice, presented a Bill for an Act to provide for, and give legal effect to, directions against artificial prolongation of the dying process. Bill read a first time. Mr Manzie moved - That the Bill be now read a second time. On the motion of the Member for Macdonnell (Mr Bell) debate was adjourned. 11. ELECTORAL AMENDMENT BILL 1988 (Serial 112): The order of the day having been read for the resumption of the debate or the question - That the Bill be now read a second time -Debate resumed. Ouestion - put and passed. Bill read a second time. The Assembly, according to Order, resolved itself into a Committee of the Whole for the consideration of the Bill. In the Committee (Chairman - Mr Dondas) The Leader of Government Business (Mr Coulter) advised that in the absence of the Chief Minister (Mr Perron) he would take carriage of the Bill, pursuant to Standing Order 77. Clause 1 agreed to. Proposed new clause ~ Mr Ede moved - That the following new clause be inserted in the Bill -"1A. PRINTING OF ROLLS "Section 24(2) of the *Electoral Act* is amended by omitting paragraph (a) and substituting the following: immediately following the fourteenth day after '(a) the issue of the writ for an election; and'.". Proposed new clause negatived. Clause 2 read. Mr Perron moved the following amendment -Omit from proposed section 26A(1) "for the preparation," and insert in its stead "for, or for the carrying out of a procedure relating to, the preparation,". Amendment agreed to. Mr Perron moved the following further amendment -Omit from proposed section 26A(1) all words after "and the Commonwealth," and insert in their stead "whether for the purpose of the rolls being used as electoral rolls for Commonwealth or Territory elections, or for any other purpose.". Amendment agreed to. Clause, as amended, agreed to. Proposed new clause -Mr Ede moved - That the following new clause be added to the Bill -"2A. ALTERATION OF ROLLS "Section 32(3) of the *Electoral Act* is amended by omitting 'on the day of the issue of the writ' and substituting 'on the fourteenth day after the issue of the writ'.". Debate ensued. Proposed new clause negatived. Title agreed to.

Bill to be reported with amendments.

The Speaker (Mr Vale) resumed the Chair and the Chairman (Mr Dondas) reported accordingly and the report was adopted. On the motion of the Minister for Mines and Energy (Mr Coulter), the Bill was read a third time and passed to be a proposed law. 12. DAIRIES SUPERVISION REPEAL BILL 1988 (Serial 99): The order of the day having been read for the resumption of the debate on the question - That the Bill be now read a second time -Debate resumed. Ouestion - put and passed. Bill read a second time. Leave granted for a motion for the third reading of the Bill to be moved forthwith. - (၉) guarantee to Australian citizens over the age of 18 the right to vote in elections subject to certain qualifications:
- (3)provide for the establishment and continuance of a system of local government, with local government bodies elected in accordance with the laws of the state and empowered to administer and to make by-laws for their respective areas in accordance with the laws of the state;
- (4) (a) extend the right given by section 80 of the Constitution to trial by jury for offences against laws of the Commonwealth, and to confer a like right to trial by jury for serious offences against the laws of the states and territories:

Clause 2 - The Attorney-General (Mr Manzie), by leave, moved the following amendments together -

Omit from proposed section 59A(1) all words after "and even though" and insert in their stead "that Act of the Commonwealth or the *Aboriginal Land Act* limits the persons or classes of persons who may enter and remain on that Aboriginal land".

Omit proposed section 59A(2) and insert in its stead the following:

"(2) For the purposes of a law of the Territory referred to in subsection (1), the persons who are not precluded by the *Aboriginal Land Rights (Northern Territory) Act 1976* of the Commonwealth or the *Aboriginal Land Act* from entering or remaining on Aboriginal land, or who are on Aboriginal land whether or not they are entitled by those Acts, or either of them, to enter or remain on Aboriginal land, are capable of constituting, and shall be deemed always to have been capable of constituting, a section of the public in relation to that land.".

Omit subclause (3) and insert in its stead the following:

"(3) Nothing in the amendment effected by subsection (1) shall be taken -

 (a) to permit a person to enter or remain on Aboriginal land who would not otherwise be entitled to do so; or (b) in any way to affect a right or entitlement of a person, given by or under the Aboriginal Land Rights (Northern Territory) Act 1976 of the Commonwealth or the Aboriginal Land Act, to enter or remain on Aboriginal land or the rights under those Acts of the beneficial owners of Aboriginal land.".

Amendments agreed to. Clause, as amended, agreed to. Title agreed to. Pill to be reported with amendments.

The Acting Speaker, (Mr Setter) resumed the Chair and the Chairman (Mr Dondas) reported accordingly and the report was adopted.

On the motion of the Attorney-General (Mr Manzie) the Bill was read a third time and passed to be a proposed law.

19. REFERENDUM ON PROPOSED AMENDMENTS TO THE CONSTITUTION - MINISTERIAL STATEMENT - STATEMENT NOTED: The order of the day having been read for the resumption of the debate on the motion of the Chief Minister (Mr Perron) (23 August 1988) - That the Assembly take note of the statement and on the amendment moved thereto by

Omit all words after "That", and insert in their stead:

the Member for Stuart (Mr Ede) (23 August 1988) viz -

"this Assembly recommends to the electors of the Northern Territory that on 3 September 1988 they vote to allow the Federal Constitution to be altered so as to:

- Allow maximum terms of four years for Members of both Houses of the Commonwealth Parliament;
- (2) (a) Provide fair elections for the House of Representatives, the state parliaments and legislatures of the mainland territories, based on the principle of 'one vote, one value' but subject to permissible limited variations in the numbers of electors in each electorate in each state or territory; and
  - (b) confer the right to vote in Commonwealth, state and mainland territory elections on all Australian citizens over the age of 18, subject to certain qualifications;
  - (c) provide for the fair determination of electoral divisions for elections for the House of Representatives, state parliaments and legislatures of the mainland territories;
  - (d) prohibit multiple voting; and
  - (e) guarantee to Australian citizens over the age of 18 the right to vote in elections subject to certain qualifications;

- (3)Provide for the establishment and continuance of a system of local government, with local government bodies elected in accordance with the laws of the state and empowered to administer and to make by-laws for their respective areas in accordance with the laws of the state;
- extend the right given by section 80 of the Constitution to trial by jury for offences against laws of the (4)(a) Commonwealth, and to confer a like right to trial by jury for serious offences against the laws of the states and territories:
  - (b) ensure that acquisition of property under state and territory laws, and acquisitions under Commonwealth law from persons in the territories, must be on just terms; and
  - (c) extend to the states and territories the existing prohibition on Commonwealth interference with religious freedom.".

Debate ensued. Question - That the amendment be agreed to - put and negatived. Question - That the motion be agreed to - put and passed.
