  - (c) for a BDO made under section 10(1)(a):
    - (i) that the charge was withdrawn, dismissed or not proceeded with; or
    - (ii) that the banned adult was found not guilty of the offence; or
  - (d) for a BDO made under section 10(1)(b) that the police DVO was revoked.
