Mr Higgins to the Minister for Housing and Community Development:

Five Year Funding Agreements

1. How many organisations have received five year funding agreements in 2017/18 and at what cost for each?

In 2017-18, no organisations received five year funding agreements.

From 1 July 2018, all of the 54 eligible organisations have been offered a five year funding agreement. Details of the organisations that have been offered five year funding agreements are tabled in Question 2.

2. What is the budget allocation for five year funding agreements in 2018/19 to what organisations and at what cost?

All organisations that are eligible for five year funding agreements have been offered a five year agreement from 2018-19. These grants are paid to services providers under the Department of Housing and Community Development's Homelessness, Homelands and Town Camps programs.
