Mr Higgins to the Minister for Infrastructure, Planning and Logistics:

Infrastructure funding figures

1. There appears to be an \$11M increase under Infrastructure Investment Delivery (BP3, p89) which is attributed to additional resourcing "to support the delivery of economic stimulus programs and additional funding to underground power lines". Given you have stated \$10M is to be earmarked for undergrounding power lines, does this mean just \$1M will go towards your much touted economic stimulus programs?

This output in the budget papers contains operational funding only for the department and does not include stimulus provided to each agency's Repairs and Maintenance Budget, Minor New Works and Capital Works. The \$11 million increase between years contains the \$10 million in grants for undergrounding power lines for the Power Water Corporation as well as approximately \$1 million in operational funding to support the delivery of the stimulus program.

2. If we're reading that wrong, please provide a breakdown of which programs the extra \$11M is going towards precisely?
