To calculate the staff numbers and the duration of employment is too administratively onerous due to the viability of arrangements for agency staff. To undertake this task would result in undue diversion of resources from service delivery. In the Department of Health, labour hire was used to meet short-term skill-specific service delivery requirements. Across the Top End Health Service and Central Australia Health Service, labour hire provided for medical and nursing staff across Hospitals, Mental Health and Primary Health Care services. Total costs are included in the below table:

Providing a FTE figure for locums is administratively excessively time consuming to collate.

Locums were employed during the two reporting periods for varying periods ranging from one week to six months across a range of regions, program areas and professions for various reasons, including covering long service leave, emergency personal leave, professional development including sabbaticals, temporary transfers, vacant positions and holiday periods (Christmas and New Year).

There are continued efforts by the Top End and Central Australia Health Services to attract, recruit and retain a suitably qualified health/medical workforce to reduce the need for locums

#### OUTSOURCING

For the reporting period 1 July 2019 to 31 March 2020:

<u>Alice Springs Hospital and Central Australia Mental Health Services</u> Alice Springs Hospital and Central Australia Mental Health Services outsourced services related to clinical report writing, clinical supervision and Human Resource and Probity consultancy services, which is expected to continue in 2020-21.

#### Katherine Hospital – Computed Topography (CT) Service A Computed Topography (CT) service in Katherine is operated by a private diagnostic firm out of Katherine Hospital. This allows services to be provided within the hospital where they were previously conducted at an external site by the service provider.

#### Katherine Hospital - Renal Dialysis

Renal Dialysis is provided by private provider *Fresenius*, on a price per treatment arrangement in a purpose built facility off Katherine Hospital. This has been in place since 2014, with a seven year service agreement which is expected to go back out to tender in early 2021.

#### Clinical Coding, Auditing and Education at Royal Darwin Hospital

A contract was awarded for Clinical Coding, Auditing and Education at Royal Darwin Hospital in 2019-20. These services were provided on site at RDH in 2019-20, however in response to the COVID-19 border closures a new contract has been awarded to facilitate remote service delivery to ensure the continuation of the program in 2020-21.

#### Top End Mental Health Service

Since May 2017, Top End Mental Health Service has operated a five bed supported accommodation facility in Darwin. Other mental health supported accommodation services in the Top End are operated within the local sector and Top End Mental Health Service is currently working with the Department of Health in order to transition the service to the NGO sector.

#### Cleaning

A contract was awarded in August 2018 for ongoing high access cleaning and external windows cleaning at Palmerston Regional Hospital due to the specialised equipment required to complete these tasks. It was not economically viable to purchase equipment and recruit staff to perform this specialised cleaning. There have been 2 high cleans and cleaning of external windows at PRH since the contract was awarded (31 March 2019 and 2 October 2019). This is expected to continue in 2020-21.

Patient Inter-Hospital Road Transport Service between PRH and RDH A contract for the provision of Patient Inter-Hospital Road Transport Service between Royal Darwin Hospital and Palmerston Regional Hospital was executed with CareFlight Limited on 28 March 2018 for 3 years (with two, 12-month extension options). The vehicles and equipment required are specialised and the transfers are time critical, requiring suitably qualified Patient Transport Officers to be available 24 hours 7 days a week. This contract continues in 2020-21.

The below response addresses Department of Health regional office staff. The administrative effort to respond in relation to regional office staff across Top End and Central Australia Health Services is excessive and would result in undue diversion of resources from service delivery.

#### **Department of Health - Office of Disability**

The Office of Disability in the Department of Health, supports Territorians with a disability, including those that are not eligible for the NDIS, through whole of government disability policy and program development, including: ongoing contribution to the implementation of the National Disability Insurance Scheme (NDIS) in the NT and monitoring and reporting against the NDIS; grant funding to organisations for the provision of peak body operations; advocacy and information services, and awards programs; secretariat support to the NT Disability Advisory Committee; NT Companion Card; and provision of forensic disability services.

<u>Regional Centres</u> Alice Springs Forensic Disability Unit Number of Positions – 45 Staff Expenditure - \$4 948 638

#### Department of Health - Mental Health, Alcohol and Other Drugs Branch

The workforce are located in major regional centres and regularly travel to remote communities. Staff coordinate the delivery of community driven alcohol harm minimisation projects called Alcohol Action Initiatives (AAI). AAIs contribute to the reduction of alcohol related harm through investment in community activities that tackle the social determinants of health. There are currently 285 AAI projects underway across 42 remote NT communities. Staff travel regularly to communities, in addition, to phone and email consultations, with community members and service providers.

### Department of Health – Territory Pathology

Territory Pathology assists healthcare staff diagnose and manage their patients. Approximately 1.8 million pathology assays are performed on public patients in the NT each year at six sites including Darwin. Pathology results can be time critical and 24/7 access to services is required for some assays. The pathology disciplines include chemical pathology, haematology and blood banking, and microbiology. Point of Care molecular testing for COVID and other infectious agents is now available in Territory Pathology regional and remote facilities. Pathology requests for other disciplines, including anatomical pathology, forensic pathology, immunology and genetics are referred to Darwin or interstate for testing.

## 1. Background

### 1.1. Where have we come from?

On the 1 July 2019, the Northern Territory completed transition to the National Disability Insurance Scheme (NDIS). The NT's transition to the NDIS was supported by the previous Ministerial Advisory Council on Disability Reform and was one of the largest reforms of its kind to occur in Australia. The reform involved the transition of responsibility for the funding and provision of disability services from the states and territories to the Commonwealth Government's National Disability Insurance Agency, and a "doubling of funding" for the specialised support needs of people with disability.

### 1.2. Where are we now?

Post 1 July 2019, the NT Government continues to support Territorians with a disability, including those that are not eligible for the NDIS, through:

- whole of government disability policy and program development;
- ongoing support to the implementation of the NDIS in the NT through an annual funding contribution of \$103.6 million;
- monitoring and reporting against the NDIS;
- provision of Community Allied Health Services for those Territorians who are not eligible for the NDIS but who have mild to moderate functional impairments;
- provision of forensic disability services; and
- grant funding to organisations for the provision of peak body operations, advocacy and information services, and awards programs;

The Minister for Disabilities leads the NT Government in its work to meet its obligations to people with disability and is supported by the Office of Disability in this role. Following the reform, the Minister for Disabilities is keen to take the opportunity to reset the framework and direction for the NT in its actions to build an inclusive community that upholds and reflects the principles of the United Nations Convention on the Rights of Persons with Disabilities. Key to achieving this will be a refreshed focus on the NT Government's commitment to the implementation of the National Disability Strategy (NDS) and the development of a NT Disability Strategy and Implementation Plan. The NDS aims to ensure opportunities for people with disability to fulfil their potential as equal citizens and provides the key priorities and actions for governments to progress towards this goal. The NT Disability Strategy will support the implementation of the NT.

### 1.3. Why do we need a Disability Advisory Committee?

Engagement of people with disability and other stakeholders is critical to establishing the NT Disability Strategy; and will ensure that the future direction is reflective of the aspirations of people with disability in the Territory.

A new NT Disability Advisory Committee (DAC) is needed to advise the Minister for Disabilities on issues of importance to people with disability in the NT. The DAC will inform and guide planning and decision-making where a government response is required to drive change. The membership of the DAC will be asked to focus on issues which are relevant and important to people with disability in the NT, which are not already being addressed at a national level.

In order to support key work to develop the NT Disability Strategy, the work of the DAC will be focused on the six key policy areas of the NDS:

- inclusive and accessible communities;
- rights protection, justice and legislation;
- economic security;
- personal and community support;
- learning and skills; and
- health and wellbeing.

### 1.4. Who do we need on the Disability Advisory Committee?

The United Nations Convention on the Rights of Persons with Disabilities identifies people with disabilities as those who have long-term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others.

The NT is unique in Australia for its demographics, diverse languages and cultures, and remoteness. In order that the DAC has the capacity to effectively undertake its role, members will represent the diversity of Territorians with disability, the regions that make-up the NT, and have lived experience and or expertise in key policy areas that are a priority for the NT.

A DAC that is representative of people with disability in the Territory requires proportional representation from each of the key stakeholder groups identified in the *Data Snapshot* below.

### Data Snapshot

- 52.1% of active NDIS participants and approximately 65% of clients of Department of Health Community Allied Health Services for people with mild to moderate disability identify as Aboriginal and/or Torres Strait Islander.<sup>1</sup>
- 100% of all the Department of Health's Forensic Disability Unit clients are Aboriginal people with disability.<sup>2</sup>
- 28% of active NDIS participants in the NT with an approved plan identify as coming from a culturally and linguistically diverse background (CALD).<sup>1</sup>
- 46% of active NDIS participants in the NT are youth between the ages of 0-18, 39% of these being below 14 or younger.<sup>1</sup>
- 24% of all active NDIS participants with an approved plan have intellectual disability as a
  primary disability, 22% have autism as a primary disability (this cohort is predominantly recorded
  within the 0-14 age group). Other disabilities which are highly represented in the NT are
  acquired brain injury (ABI) (8%), cerebral palsy (8%) and psychosocial disability (6%).<sup>1</sup>

Aboriginal and Torres Strait Islander people, here on referred to as Aboriginal people, represent 27 per cent of Territorians and more than half of people with disability in the Territory. The NT is unique in Australia, in that Aboriginal people form the majority of clients of a number of key services across the NT, including those provided by the health and justice systems, and the majority of the population in remote and very remote areas. Seventy three per cent of the Aboriginal population live outside of Darwin, Palmerston and Alice Springs and as a result experience multiple barriers to equitable access to services, including cultural and geographic.<sup>3</sup>

The NT covers 1.421 million km<sup>2</sup>, an area much larger than New South Wales, Victoria, Tasmania and the Australian Capital Territory combined. Language and culture are diverse in the Territory with over 200 Aboriginal languages spoken. In order to reflect the diversity in place and culture, representation on the DAC will be sought from a range of regions and reflect the high proportion of the population that live in remote and very remote areas.

People from culturally and linguistically diverse (CALD) backgrounds represent a quarter of people with disability accessing NDIS specialist disability services in the NT. This is reflective of the NT population, 23.9 per cent of people in the NT have both parents born overseas and approximately 42 per cent of people speak a language other than English at home, noting that this includes those people who speak Aboriginal languages.<sup>4</sup>

Youth (0-17 years) form nearly half of the NT population accessing specialist disability services and the majority of clients accessing NT services for people with mild to moderate disability. Children and young people (0-25 years old) also form a significant number of the NT general population.

### Data Snapshot

- The median age of Territorians is 32.
- 40% of the children and young people in the NT are Aboriginal.
- Children and young people (0-25) make-up approximately 32% of the NT non-Indigenous population, and 50% of the NT Aboriginal population<sup>5</sup>.

The issues and priorities for young people are often specific to their age group. Key issues for young people include exit around education and life transition points from home to school and school to post school options and employment. Young people are the target group for specialist and community allied health early intervention supports to help improve the development of children and reduce the needs for supports later in life. These age groups experience a high prevalence of disabilities such as Autism and Foetal Alcohol Syndrome.

## 2. Terms of Reference

### 2.1. Role

The NT Disability Advisory Committee (DAC) is a non-statutory advisory group to the Minister for Disabilities. The DAC will:

- Represent the diversity of people with disability in the NT and their interests and provide advice to the Minister for Disabilities on issues affecting them;
- Provide advice on improving the representation of Aboriginal and Torres Strait Islander people (here on referred to as Aboriginal people) with disability in the NT and nationally and provide advice to support positive outcomes for Aboriginal people with disability;
- Establish collaborative relationships with people with disability, their families and other unpaid carers, organisations, government agencies and the wider community;
- Provide advice on strategies that raise community awareness of the rights of people with disability including the United Nations Convention on the Rights of Persons with Disabilities and the National Disability Strategy and the role of government and community in promoting these rights;
- Provide advice on engagement strategies, materials and activities undertaken by the Office of Disability (OoD) and participate in these activities;
- Provide advice on issues related to the access and delivery of mainstream services to people with disability in the NT;
- Alert the Minister for Disabilities to emerging issues, potential risks and opportunities related to the ongoing implementation of the National Disability Insurance Scheme; and
- Participate in the review of the terms of reference for the DAC and provide advice to support the Minister for Disabilities in ensuring the effectiveness of the DAC in undertaking its role.

## 2.2 Authority to Act

The DAC is established as a non-statutory advisory body. The DAC does not have any delegated powers to act on behalf of, or commit, the Minister for Disabilities or the Northern Territory Government to any actions.

The DAC is not a legal entity in its own right and does not have any NT public sector financial, procurement, contracting or human-resource delegations.

## 2.3 Membership

### 2.3.1 Structure

The DAC will comprise up to 12 members, including the Chair and Vice Chair, plus ex-officio members.

The Minister for Disabilities has the discretion to appoint additional members, including ex-officio members, and to invite experts to advise the group on particular issues.

Opportunity for emerging leaders will be provided on request to the OoD on a temporary basis. This may include people with disability who are interested in representing the views of people with disability in the future.

## 2.4. Chair

The DAC will have a Chair and Vice Chair. In the temporary absence of the Chair, the Vice-Chair is to act in the position of Chair.

### Role of the Chair

The Chair will:

- represent the DAC including in any public context;
- facilitate orderly and constructive discussions between members on matters within the Terms of Reference;
- liaise with the OoD and DAC Secretariat;
- assist members to work together as a group by:
  - facilitating discussion;
  - o ensuring all members have equal opportunity to contribute ideas, opinions and concerns;
  - o drawing participation from all members;
- maintain a positive and constructive atmosphere at meetings by encouraging courtesy, respect and openness;
- seek to resolve conflict within the group and provide feedback as necessary to group members on expressed opinions or actions;
- liaise with the DAC Secretariat to develop meeting agendas and ensure that any action required is appropriately assigned and progressed; and
- work with the DAC Secretariat to inform the Minister for Disabilities about the priorities and work of the DAC through meetings and correspondence.

The Chair may also conduct business between meetings on behalf of the DAC. The Chair may delegate this to other members, as required.

### Composition and Representation

The DAC is to represent the diversity of people with disability in the NT. Membership is to be established with consideration of the following:

- No less than 60% of members will have a disability;
- No less that 50% of members will identify as Aboriginal;
- No less than 20% of members will identify as having a Culturally and Linguistically Diverse (CALD) background;
- No less than 50% of members will be young people and children, noting that children may be represented by carers and family;

- No less than 30% of members will reside in a remote area or have a connection to or lived experience in a remote area (remote for this purpose being outside of the Greater Darwin Area, Alice Springs and Katherine);
- No more than 40% of members will be from the Greater Darwin Area;
- Carers of people with disability; and
- Equitable gender representation.

Members of the DAC are to have expertise and/or lived experience in regards to interactions of people with disability with key government service systems, including but not limited to:

- the NT Justice System;
- the NT Health System;
- the NT Education System; and
- the National Disability Insurance Scheme.

### Ex-Officio

A representative of the OoD, being the Director of the OoD or a delegate, will be an ex-officio member of the DAC.

Temporary ex-officio members may be appointed from government agencies where their membership will support the DAC in progressing whole of government initiatives to support people with disability.

### Terms of Appointment

Individual community members, including the positions of Chair and Vice Chair are appointed by the Minister for Disabilities.

Appointments of incoming members are staggered, to ensure corporate knowledge is not lost and will be for a term of one, two or three years, with the option to extend up to a maximum of six years membership.

### Remuneration

While not statutory appointments, remuneration of members will be consistent with the NT Assembly Members and Statutory Officers (Remuneration and Other Entitlements Act) 2006 Statutory Bodies Classification Structure.

Members will be reimbursed at the rate for a Class C – Advisory and Review Body – Level C3 Ministerial Assistance (LC3) for attendance at meetings. The daily rate at the point of drafting this Terms of Reference is:

- Chair person: \$304
- Other member: \$228

Expenses associated with attendance at meetings, such as travel costs, accommodation and meals, will be funded by the DAC Secretariat.

Members will seek agreement in advance, through the DAC Secretariat, for any out-of-session expenses.

### Operation

### Meetings

The DAC meets three times a calendar year with at least one meeting a year conducted face to face. Meetings are to ensure equitable opportunity for members to participate by ensuring each member's specific access requirements are met. This may require additional flexibility and adjustments to the operation of meetings.

A draft agenda will be developed prior to each meeting by the DAC Secretariat in consultation with the Chair. In developing the agenda, consideration will be given to any direction provided by the Minister for Disabilities. The agenda and papers are to be circulated to members no less than one week prior to the meeting.

Meetings are to be facilitated by the Chair, or in their absence, the Vice-Chair. Where the Vice-Chair is also not present, a member nominated by the Chair will temporarily act as the Chair.

Whenever possible, decisions of the DAC are to be made by consensus. If consensus cannot be reached, decisions will be made by a majority vote of those members present. The advice provided to the Minister for Disabilities will include the diverse range of opinions of members.

A member who abstains from voting, or does not agree with the majority ruling, can request to have their concerns noted in the minutes of the meeting.

### Quorum

In order for recommendations to be made at a meeting, there is to be a quorum of no less than half the total current number of members plus one.

### Leave of absence and apologies

If a member is unable to attend a meeting, they must submit an apology to the DAC Secretariat. Apologies will be noted in the minutes of the meeting.

Members may apply to the Chair, through the DAC Secretariat, for a leave of absence from their DAC responsibilities for up to four months. For a period of absence of longer than four months from DAC responsibilities, the request must be submitted through the DAC Secretariat to the Minister for Disabilities for agreement.

If a member fails to attend three consecutive meetings without leave from the Chair, their term may be cancelled and the place may be opened to a new member.

### Carers and professional support staff

DAC members may, as required, have carers or professional support staff (here on referred to as support person) assist them to undertake and participate in activities relevant to their membership and this Terms of Reference.

Travel and accommodation expenses related to supporting a member undertake the responsibilities of their position will be funded by the DAC Secretariat.

The role of the support person is to:

- Assist the member to participate to their full capacity in all activities of the DAC and to support the member to act for themselves;
- Assist the DAC Secretariat to understand the supports and adjustments the member may need;
- Assist in the supported decision making of members:
  - Ensuring the member knows they have a decision to make;
  - Explaining information;
  - Assisting in ensuring information is in an understandable format;
  - Helping the member to identify and explore relevant options;
  - Helping the member to weigh up the decision, including thinking about the good and bad things that could happen as a consequence of the decision; and
  - Making sure people (members, Chair) listen and understand once the decision is made.
- The support person may not attend as a proxy to the member, nor may they vote on a matter on behalf of the member.

### Secretariat Support

Secretariat support will be provided by the OoD, within the Department of Health. The DAC Secretariat is responsible for:

- Ensuring accessibility and inclusivity to all aspects of DAC operations for each member of the DAC, including meetings, correspondence, communication, technology, the built environment and other arrangements related to members' participation in meetings, including but not limited to travel, accommodation and attendance options;
- Developing agendas in consultation with the Chair and the Minister;
- Distributing the agenda and meeting papers in appropriate formats;
- Support the DAC in development of a work-plan and subsequent implementation, monitoring and reporting;
- Taking minutes and distributing them to DAC members within two weeks of meetings;
- Monitoring action items arising from DAC business and assisting in their implementation, including liaising between the DAC, government agencies and other representative groups;
- Reporting on the business of the DAC (see reporting);
- Arranging venues and refreshments for meetings; and
- Arranging remuneration for members.

### Reporting

Following each meeting, the DAC Secretariat will:

- Compile the minutes on the discussions, actions and recommendations of the DAC, including an update on progress against the DAC work-plan;
- Provide the draft minutes to the Chair for approval to circulate to members within two weeks from the date the meeting was held. Draft minutes will be approved as final at the next DAC meeting;
- Provide the draft and DAC approved minutes to the Minister for Disabilities for noting; and
- Arrange for DAC communique to be circulated and published on the Internet.

### Official Business and Representation of Disability Advisory Committee Views

The Chair may represent the DAC at meetings and forums when attending on behalf of the DAC. The Chair or delegated members must represent the views of the DAC in the public domain.

All significant correspondence of the DAC must be approved by the Chair and the Minister for Disabilities. Formal speeches and papers that are delivered by a member on behalf of the DAC must be approved by the Chair and the Minister for Disabilities prior to being presented publically.

Any information to be released to the media on behalf of the DAC must first be approved by the Chair and the Minister for Disabilities.

Members representing the DAC will report back to the DAC on official activities.

### Code of Conduct

DAC members are expected to conduct themselves in accordance with the Northern Territory Public Sector Principles and Code of Conduct.

### Confidentiality

Unless otherwise indicated, all papers and minutes are confidential and the DAC will determine what papers are marked for release at the end of each meeting, or in subsequent meetings. Members may be provided with other confidential material which they should treat with the care and discretion and cannot disclose to anyone outside the DAC.

### Conflict of interest

A conflict of interest may occur where a member has a direct financial, or other interest, in items for consideration by the DAC.

A member must disclose to the Chair any situation that may lead to a conflict of interest, a potential conflict of interest, or a potential perceived conflict of interest. The Chair will decide if the member needs to be excluded from discussion related to the item where conflict of interest may exist.

The Minister for Disabilities has the discretion to suspend or terminate a member's appointment if there is an identified conflict of interest.

### Resigning from the Disability Advisory Committee

Members may resign from the DAC at any time. All resignations must be provided in writing to the Minister for Disabilities with a copy provided to the Chair. The appointment of replacement members is at the Minister's discretion.

### Termination and dissolution

The Minister for Disabilities retains the discretion to terminate a member's appointment to the DAC for serious breaches of attendance or the Northern Territory Public Sector Principles and Code of Conduct, and/or an identified conflict of interest.

The Minister for Disabilities may dissolve the DAC at any time by notice in writing to members.

### Review of the Terms of Reference

The Terms of Reference will be reviewed annually. The Terms of Reference may also be varied by the Minister for Disabilities as required, where this will support the operation of the DAC.
