REVIEWS AND INQUIRIES

- 43. Details of all reviews and inquiries completed or commenced during the 2023/24 financial year, also providing the following information:
 - a) The Terms of Reference
 - b) The criteria for selection of all panel members
 - c) The composition, qualifications and state or territory of residence of the persons undertaking the review/inquiry
 - d) The cost of the review/inquiry
 - e) How the information was/is accumulated to contribute to the review/inquiry
 - f) If completed, when, the outcome and whether the report has been tabled in the Legislative Assembly
 - g) If not completed when this is expected

Two reviews were completed during the 2023-24 financial year as detailed below:

Review the Bail Act 1982, Sentencing Act 1995, Juries Act 1962 and Parole Act 1971

- a) To conduct a review of the *Bail Act 1982* (NT), *Sentencing Act 1995* (NT), *Juries Act 1962* (NT) and *Parole Act 1971* (NT) to address, resolve and to provide reports that recommends legislative reforms that are found to be unfair, discriminatory or detrimental to Aboriginal people:
 - A report identifying where and how the application of certain legislative provisions directly or indirectly leads to discriminatory, unfair and detrimental outcomes to Aboriginal people and identifying legislative and policy reforms.

- An evidence-based, criminological assessment, using existing data sources to validate identified issues. Where there are gaps in data, these gaps should be identified.
- Perspectives and data should be NT-wide, or applicable to the whole of NT.
- Stakeholder engagement needs to be targeted to complement existing data.
 Stakeholder engagement will primarily focus on two groups:
 1) professionals with extensive practice experience directly relevant to the issues in consideration; and 2) Aboriginal people and groups who can provide insight into the impacts on Aboriginal Territorians.
- The report should include consideration of victim, offender and community perspectives, including through a gender lens.
- The report should consider relevant International Conventions that Australia has ratified or is a signatory to.
- b) Under the Aboriginal Justice Agreement (AJA) a tender process was adopted. The criteria for selection for all panel members was relevant knowledge of the subject matter and experience in procurement.
- c) The Aboriginal Resource Development Services (ARDS) in partnership with Social Ventures Australia (SVA) provided best value for the Territory and has been operating for 50 years in the NT with 98 per cent of the total workforce based in the NT, and 50 per cent Aboriginal. One consultant identifies as a First Nations man for the consultancy project. ARDS have conducted legal analysis and legislative reviews such as the *Interpretation Act 1978* (NT), Criminal Code (NT), *Evidence Act 1939* and mandatory reporting of harm against children. ARDS project lead holds a strong reputation in the NT legal profession as a criminal lawyer and community legal educator. SVA allocated two lawyers.
- d) The contract value for the review was \$119 460 GST inclusive.
- e) The information that contributed to the review was derived through:
 - Initial meetings with the Aboriginal Justice Unit to refine and finalise scope, work plan and stakeholder engagement and to identify key documents.
 - Completing a high-level review of relevant documents, defining key concepts informing the scope of works being definitions of 'Aboriginal Territorians' and 'unfair, discriminatory or detrimental" and seeking approval through the Aboriginal Justice Unit (AJU).
 - Developing a list of key issues to be addressed in the report and relevant data and draft report structure for approval.
 - Analysing data with reference to identified issues, preparing interview guides and undertaking stakeholder engagement.

- Synthesise qualitative and quantitative findings, drawing preliminary conclusions for discussion with AJU, and reflecting on any changes necessary to the draft report structure.
- Drafting the report, based on desktop research, data analysis and consultation findings and providing to the AJU for feedback.
- f) The AJU received a draft report considered by the AJA Executive Action Committee and key stakeholders in August 2023. Further feedback is being sought and will be consolidated to provide to ARDS to finalise the report.
- g) The final report has not been received at this stage.

Review of psychosocial hazards in the Crime Victims Services Unit workplace

- a) To conduct an assessment of the psychosocial hazards in the Crime Victims Services Unit (CVSU) workplace, providing a high-level report with an overview and a summary of the consultation process, identified hazards and recommendations.
- b) There was no panel. Due to the specialist nature of the work a procurement exemption was requested from the Chief Executive Officer of the Department under section 6.2.2 E6.2 of the Procurement Rules to use direct contracting to engage a provider recommended by the Executive Director, NT WorkSafe.
- c) The provider undertaking the review is based in the NT and has extensive experience in working with Work Health and Safety requirements. This includes ten years running their Territory business and 12 years working in senior roles within NT WorkSafe prior to that.
- d) The review cost a total of \$19 800.
- e) The information that contributed to the review was derived through:
 - Initial meetings with the Director of CVSU to provide context for the review, particular issues to be considered and the consultation process.
 - Completing an on-site audit of the CVSU including a review of the current situation and physical office environment and undertaking consultation with several employees.
 - Completion of a survey provided to all employees at CVSU.
 - One-on-one phone discussions facilitated for those employees who requested it.
- f) The report was completed on 20 November 2023 and a psychosocial management plan has been drafted in response to the recommendations. The report has not been tabled in the Legislative Assembly.
- g) The final report has been received.
