### SUBORDINATE LEGISLATION NO. 13 OF 2017

#### POLICE ADMINISTRATION (FEES) AMENDMENT REGULATIONS 2017

#### Purpose

The *Police Administration (Fees) Amendment Regulations 2017* increase fees and charges in relation to the provision of national police certificate services and taking fingerprints of a person on the request of the person.

#### Summary of key provisions

As part of the 2017-18 Budget, the NT Government increased all legislated fees and charges by 20% where revenue is returned to the Central Holding Authority. An amendment to the *Police Administration (Fees) Regulations* is required to give effect to the fee increases as follows:
