### SUBORDINATE LEGISLATION NO. 21 OF 2017

#### ***MOTOR VEHICLES (FEES AND CHARGES) AMENDMENT REGULATIONS (NO. 2) 2017***

##### **Purpose**

The *Motor Vehicles (Fees and Charges) Amendment Regulations (No. 2) 2017* increase specific fees and charges for certain services provided by the Motor Vehicle Registry (MVR) effective from 1 July 2017.

##### **Summary of key provisions**

The Regulations amend the *Motor Vehicles (Fees and Charges) Regulations* in order to:

- increase the MVR administration fee by \$2 (proposed charge \$12);
- increase the light vehicle and trailer inspection fee by \$5 (proposed charge \$49);
- increase the heavy vehicle inspection fee by \$20 (proposed charge \$112); and
- increase the heavy vehicle general permit of exemption fee by \$20 (proposed charge \$64).

The Regulations provide the fees and charges to be expressed as revenue units. One revenue unit is currently \$1.15.

##### **Legislative Authority**

Section 138(1)(af) of the *Motor Vehicles Act*.
