- His party's dealings with the Australian Hotels Association (NT) and the secretive manner in which his Government formulated the regulations of section 33ab(1) of the Liquor Act preventing Dan Murphy's from obtaining a store licence and entering the retail liquor market in the Northern Territory.
- The Assembly notes that his actions constitute a breach of Clauses 3.3, 3.4, 3.5, 5.2, 5.3 and 6.2 of the Ministerial Code of Conduct as well as Clauses 5, 10 and 11 of the Legislative Assembly Members' Code of Conduct.
