Mr Higgins to the Minister for Infrastructure, Planning and Logistics:

Land Development Corporation Budget queries

1. The LDC engaged 18 consultants to the tune of \$727,838. What work did Aurecon Australia do for \$157,000?

Local company Aurecon were engaged three times in late 2017-mid 2018 for early conceptual design of industrial sub-divisions at East Arm. One at Hamaura Road, another adjacent to Casey St and the third being the Marine Service Area on Berrimah Road adjacent LDC's Common User Facility.

 The LDC clocked up \$21,190 worth of interstate travel in the reporting period for workshops and conferences – who attended the six conferences listed?

3. What are the three residential projects managed (BP3, p102)?

Kilgariff Estate, Alice Springs Zuccoli Village, Zuccoli 7 Waratah Cres, Fannie Bay

4. What future land release options for residential development are planned for the major regional centres – Darwin, Katherine, Tennant Creek, Alice Springs and Nhulunbuy in the next year?

Kilgariff Estate, Alice Springs – LDC has completed development of all land in Stages 1A and 1B. LDC does not own or have rights to any further land in Kilgariff but is in consultation with the Department of Infrastructure, Planning and Logistics regarding a potential Stage 2.

Zuccoli Village, Zuccoli - LDC is developing Stage 1 of Zuccoli, known as Zuccoli Village in Joint Venture with Urbex Pty Ltd. Stage 1 has sufficient land for approximately 800 lots and to date 440 lots have been developed. The remaining 360 lots are expected to be developed over the next 5-6 years.

7 Waratah Cres, Fannie Bay – LDC owns this 14,000m² site which is zoned MR (Medium Density Residential). Over the next few years, when market conditions dictate, LDC will develop this land, in partnership with the private sector.

Other than these three projects LDC does not own or have access to land zoned for residential uses.

5. Please report on the work of the \$14.3M Multi-User Barge Ramp - has it been a worthwhile investment for the LDC? Will it be affected by development of the SLAMI?

The Multi User Barge Ramp was constructed in cooperation with the Department of Defence who contributed the bulk of the design and construction funds by way of a grant to LDC in return for guaranteed annual access. LDC's contribution was in the form of land, management and ongoing maintenance. When not being used by Defence, the ramp is available for use by private operators. The barge ramp is a major

component of the Common User Facility, providing marine access to 9 hectares of hardstand. Overall, the ramp has been a very worthwhile investment by LDC.

The SLAMI is proposed to be constructed on land adjacent to the barge ramp. The two facilities will serve different purposes and complement each other. They are proposed to be interconnected and both will connect to LDC's Common User Facility hardstand and on to LDC's proposed Marine Service Area further to the north.

6. How many consultants have been used for the development of the Marine Industry Park at East Arm?

For the 2017-18 Financial Year LDC engaged 7 locally based consultants for the development of the Marine Industry Park at East Arm.
