GUIDELINES FOR ISSUING NORTHERN TERRITORY FLAGS

NORTHERN TERRITORY FLAG

- Organisations seeking to obtain a Territory flag should be advised to direct such request through their local Member of the Legislative Assembly (MLA) who will advise the Protocol office.
- Director of Protocol will issue a flag on the member's recommendation.

NATIONAL FLAG

• Organisations seeking to obtain a National flag should be directed to their local Federal Government Representative.

OTHER FLAGS

• Protocol does not provide any flags other then the Northern Territory flag

There is a general expectation that an organisation requesting a flag will display the flag on an exterior flagpole or in halls or public meeting rooms in the correct manner.

REQUESTING FLAGS

Upon receiving such a request, the MLA should confirm the bona fides and the eligibility of the organisation concerned. If the Member considers the organisation qualifies within the terms set out below, then a request should be made in writing to the Director of Protocol. The Protocol Unit will then arrange for the supply of a flag to the Member, for personal presentation to the organisation.

The cost of the flag will be recovered from the member's office.

ELIGIBLE ORGANISATIONS

The following list indicates the type of organisation that may be eligible for the issue of a free flag. Private Schools Scout Groups Girl Guides Voluntary Youth Organisations Voluntary Philanthropic Organisations Voluntary Sporting Organisations Churches Community Service Groups Ethnic Organisations Ambulance Services

Requests from all other organisations will be considered on their merits.

Government Departments ie, Schools, Police Fire, Services etc do not qualify for free flag issue and should obtain funding for flags through the normal budget process. Protocol will provide the flag once a cost code has been received.

Under this program flags are not available to businesses, commercial enterprises or private individuals.

RESPONSIBILITY OF DIRECTOR OF PROTOCOL

The Director of Protocol is responsible for administering the free flag scheme, in accordance with these guidelines, including:

- Assessing the eligibility of organisations and determining whether a free flag is to be issued.
- Assessing requests for early replacement of worn and damaged flags
- Arranging the purchase of Northern Territory flags.
- Maintaining a database for the distribution of flags.

FLAG REPLACEMENT

Flags should generally last for four years. When they become faded, worn or go missing, MLAs may make a recommendation to the Director of Protocol for a replacement.

FLAG LOAN SERVICE

State Flags are not provided for use overseas or to interstate bodies.

All Australian State and Territory Protocol units have Northern Territory flags available for loan.

The Protocol Unit operates a flag loan service. Flags may be loaned to community organisations for short periods for specific purposes, eg national sporting events.

Requests for short term flag loan should be directed to the Protocol Unit. Persons who borrow flags will be required to sign the flag loan register and agree to return the flag in good order. Failure to do so will result in that person being responsible for replacing the flag.

FLAG PROTOCOL ADVICE
