In 2020-21 the LDC is considering engaging one or more local licensed real estate agents to act on LDC's behalf to assist LDC to sell and lease LDC industrial land and buildings.

A 12 month contract for these services is being considered, with a further 12 month extension option.

Licensed real estate agents would supplement LDC's existing in-house sales and leasing arrangements and complement use of licensed real estate agents for residential projects.

The use of local licensed real estate agents would also provide support for this important sector of the Territory economy.

Marine Industry Park

Centrally positioned on Australia's northern coastline, the Marine Industry Park is the only significant vessel servicing point between Cairns and Perth. Strategically located within Darwin's deep water harbour, the Marine Industry Park has the potential to deliver over 100 hectares of waterfront industrial land to support marine maintenance, servicing and logistic activities.

The Northern Territory Government is committed to deliver the largest ship lift in Northern Australia by 2023. To support the Ship Lift, planning approval has been secured for the Marine Service Area being purpose built industrial subdivision to accommodate large vessel maintenance and fabrication workshops.

Centrally located between the Ship Lift and serviced lots of the Marine Industry Park is the established Common User Facility providing nine hectares of secured hardstand and a barge ramp. The interface between facilities is designed to allow for the smooth transport of vessels, modules and large equipment.

Adjacent to major onshore gas developments and offshore supply bases, the Marine Industry Park provides a unique opportunity to establish and capitalise on Darwin's expanding oil and gas, marine services and defence industries. Serviced lots within the Marine Industry Park will be available by 2022 for maintenance, servicing and support industries.

Value for Territory (VFT) audit for the 2018 calendar year

The audit found that the Land Development Corporation (LDC) demonstrates an ethos that aligns with the values of the Northern Territory Government procurement framework in pursuit of its strategic objectives to drive economic growth in the Northern Territory, particularly with regard to defensible decision making, adherence to probity principles and supporting local business.

The audit identified a small range of minor non-compliance issues which largely relate to procedural inconsistencies and record keeping practices. These are most predominant across the Tier 1 activities, for which the vast majority of transactions exist during the period.

An overall assessment of the findings notes areas for improvement but does not identify any significant risk in fundamental practice, rather that further education, systems, document control and procedures could be refined and improved.

Value for Territory (VFT) audit for the 2019 calendar year

The audit identified minor indiscretions in low risk activities and sporadic gaps in document control. In addition, it was determined that LDC will benefit from improvements being implemented based on the observations made within the 2018 audit. LDC should continue to improve in the areas identified, through the use of standard processes and forms, and should capitalise on enhanced use of its existing systems wherever possible.

The audit concluded that LDC demonstrates a culture and attitude that accords with the Buy Local Policy and Procurement Rules through the delivery of its business.

It is pertinent to note that due to the limited time between the 2018 audit and 2019 audit, the implementation and flow through benefits of the process improvements identified in the 2018 audit were unlikely to become evident in the 2019 audit. These improvements will take effect in forward years.
