Mr Vowles to the Minister for Lands, Planning and the Environment:

Crown Land Sale

- 1. Would you provide a schedule on the sale of all Crown land in 2013/14 showing:
 - a) the most recent market value determined for each lot prior to auction
 - b) the reserve price determined for each lot prior to the auction.

Response

Crown land is sold under the provisions of the *Crown Lands Act* and in line with relevant Government policies.

Crown land that is identified for strategic release to support the economic growth of the Northern Territory through the delivery of new residential and industrial estates is released via a public competitive process.

Crown land is also released through Direct Sales and Community Land Grants which are application based processes. These are for the purposes of supporting community initiatives (community land grant scheme) as well as commercial development (direct sale). Details of Direct Sales and auctions are provided.

Valuation – where land is sold through a public competitive process like an auction or through expressions of interest, the sale price represents *market value*.

Where land is sold through the Direct Sale process, an independent valuation of the land is sought prior to sale and those valuations are recorded as *market value*.

In regional locations where there are often long periods between land sales it can be difficult to make an accurate determination of market value for land. Ultimately, a public competitive sale (ie auction) is the only reliable method for determining actual market value.

Reserve prices are set based on comparable sales data (where available) and in consultation with the auctioneer based on market feedback. Reserve prices are not disclosed. This is consistent with private commercial practice.
