Tuesday 19 August 1980

THE THIRD LEGISLATIVE ASSEMBLY assembled in the Legislative Assembly Chamber at 2.00 p.m. on Tuesday 19 August 1980, being the first day of the meeting of the Third Assembly for the dispatch of business pursuant to the Notice set out hereunder:

NOTICE FIXING THE TIME FOR THE HOLDING OF THE FIRST SESSION OF THE THIRD LEGISLATIVE ASSEMBLY

Mr Perron (Treasurer) seconded the motion and Mr MacFarlane (Elsey) informed the Assembly that he accepted nomination.

Mr Isaacs (Leader of the Opposition) proposed to the Assembly for its Speaker Miss D'Rozario and moved -

That the member for Sanderson, Miss D'Rozario, do take the Chair of this Assembly as Speaker.

Mr Perkins (Macdonnell) seconded the motion and Miss D'Rozario (Sanderson) informed the Assembly that she accepted nomination.

The time for proposals having expired -

Bells rung and ballot conducted.

The Clerk of the Assembly announced the result of the ballot as Mr MacFarlane 11 votes, Miss D'Rozario 8 votes, and declared Mr MacFarlane elected to the office of Speaker in accordance with standing order 6.

Mr MacFarlane thanked the Assembly for the honour it had conferred upon him and thereupon sat in the Chair.

4. ATTENDANCE OF HIS HONOUR THE ADMINISTRATOR: Mr Speaker and members of the Assembly were received by His Honour the Administrator within the precincts of the Assembly.

Mr Speaker presented himself as the choice of the Legislative Assembly to His Honour the Administrator who congratulated him upon his election and handed to Mr Speaker his authorization to administer oaths and affirmations.

Mr Speaker and members returned to the Chamber.

5. AUTHORIZATION TO ADMINISTER OATHS AND AFFIRMATIONS: Mr Speaker informed the Assembly that he had presented himself to His Honour the Administrator and had received from His Honour the following authorization which was laid on the Table:

His Honour the Administrator entering the Chamber, Mr Speaker left the Chair and His Honour delivered, from the Chair, a speech declaring the causes of his calling the Assembly together.

His Honour then left the Chamber.

- 8. OPPOSITION OFFICE HOLDERS STATEMENT: Mr Isaacs (Leader of the Opposition), by leave, made a statement relating to the office holders in the Opposition.
- 9. HOLIDAYS AMENDMENT BILL 1980 (Serial 15): Mr Everingham (Chief Minister), by leave, presented the Bill which was thereupon read a first time.

On the motion of Mr Everingham the second reading of the Bill was made an order of the day for a later day.

- 10. ADMINISTRATOR'S SPEECH: Mr Speaker informed the Assembly that he had received a copy of His Honour the Administrator's speech.

Mr Isaacs (Leader of the Opposition) seconded the motion and was granted leave to continue his remarks at a later hour.

Debate adjourned (Mr Robertson) and the resumption of the debate made an order of the day for a later hour.

12. ELECTION OF CHAIRMAN OF COMMITTEES: Mr Everingham (Chief Minister) proposed to the Assembly for its Chairman of Committees the member for Port Darwin, Mr Harris, and moved -

That the member for Port Darwin, Mr Harris, be appointed Chairman of Committees of this Assembly.

Mr Perron (Treasurer) seconded the motion and Mr Harris informed the Assembly that he accepted nomination.

Mr Isaacs (Leader of the Opposition) proposed to the Assembly for its Chairman of Committees the member for Victoria River, Mr Doolan, and moved -

That the member for Victoria River, Mr Doolan, be appointed Chairman of Committees of this Assembly.

Mr Perkins (Macdonnell) seconded the motion and Mr Doolan informed the Assembly that he accepted nomination.

There being two nominations, Mr Speaker ordered that a ballot be conducted.

Bells rung and ballot conducted.

Mr Speaker announced the result of the ballot as Mr Harris 11 votes, Mr Doolan 8 votes, and declared Mr Harris elected to the position of Chairman of Committees.

Members congratulated Mr Harris who made his acknowledgements to the Assembly.

13. STANDING ORDERS COMMITTEE - APPOINTMENT: Mr Robertson (Minister for Education), by leave, moved -

That, pursuant to standing order 15, Mr Speaker, Mr Dondas, Mr Robertson, Mr Isaacs, and Mr Perkins be appointed as the Standing Orders Committee.

Question put and passed.

14. COMMITTEE OF PRIVILEGES - APPOINTMENT: Mr Robertson (Minister for Education), by leave, moved -

That, pursuant to standing order 16, Mr Perron, Mr Tuxworth, Mr Harris, Mr Doolan, and Miss D'Rozario be appointed as the Committee of Privileges.

That the committee have power to send for persons, papers and records, to sit during any adjournment of the Assembly and to adjourn from place to place.

Question put and passed.

15. HOUSE COMMITTEE - APPOINTMENT: Mr Robertson (Minister for Education), by leave, moved -

That, pursuant to standing order 17, Mr Speaker, Mr Dondas, Mr Vale, Mrs O'Neil, and Mr Leo be appointed as the House Committee.

Question put and passed.

16. PUBLICATIONS COMMITTEE - APPOINTMENT: Mr Robertson (Minister for Education), by leave, moved - 4 That, pursuant to standing order 18, Mr Steele, Mrs Padgham-Purich, Mr Vale, Mr B. Collins, and Mr Doolan be appointed as the Publications Committee.

That the committee have power to sit during any adjournment of the Assembly.

Question put and passed.

17. SUBORDINATE LEGISLATION AND TABLED PAPERS COMMITTEE - APPOINTMENT: Mr Robertson (Minister for Education), by leave, moved -

That, pursuant to standing order 19, Mr Harris, Mrs Padgham-Purich, Mr D.W. Collins, Mr Perkins and Mrs Lawrie be appointed as the Standing Committee on Subordinate Legislation and Tabled Papers.

Question put and passed.

18. ADJOURNMENT: Mr Robertson (Minister for Education) moved -

That the Assembly do now adjourn.

Question put and passed.

And then the Assembly at 3.16 p.m. adjourned until tomorrow at 10.00 a.m.

That during the present session of the Assembly, notwithstanding any previous resolution of the Assembly, Mr Speaker may, at his discretion, appoint a time for holding a sittings of the Assembly, which time shall be notified to each member in writing.

Question put and passed.

11. LEAVE OF ABSENCE FOR MEMBERS - SESSIONAL ORDER: Mr Robertson (Minister for Education), by leave, moved -

That if the time between the determination of one sitting day and the commencement of the next sitting day is two months or more, on any occasion during this session, all members of the Assembly shall be deemed to have been granted leave of absence for such interval between the sitting days.

12. BROADCASTING OF PROCEEDINGS - SESSIONAL ORDER: Mr Robertson (Minister for Education), by leave, moved -

That this Assembly, for the purposes of section 24 of the *Legislative Assembly (Powers and Privileges) Act*, authorizes the broadcasting of the Budget Speech of the Treasurer on Thursday 21 August 1980 and for the remainder of this session authorizes the broadcasting of proceedings on such occasions as Mr Speaker may determine.

Question put and passed.

13. AUSTRALIAN CONSTITUTIONAL CONVENTION - APPOINTMENT OF DELEGATES:
Mr Everingham (Chief Minister), by leave, moved -

That the delegates of this Assembly to the Australian Constitutional Convention be Mr Everingham and Mr Isaacs and that in the event that either delegate is unable to attend the Convention, Mr Robertson act as substitute delegate.

Debate ensued.

Mr Isaacs (Leader of the Opposition) moved -

That the motion be amended by omitting the words after "be" and substituting the words "the Chief Minister and the Leader of the Opposition or their respective nominees".

Debate ensued.

Question put and passed.

Motion, as amended, agreed to.

14. AUSTRALASIAN STUDY OF PARLIAMENT GROUP - APPOINTMENT OF REPRESENTATIVES:
Mr Everingham (Chief Minister), by leave, moved -

That, during the full term of this Assembly, the Legislative Assembly of the Northern Territory be represented at meetings of the Australasian Study of Parliament Group, not conflicting with sittings of the Assembly, by two Members, one nominated by the Chief Minister and one nominated by the Leader of the Oppostion for each meeting.

Question put and passed.

15. SESSIONAL COMMITTEE ON THE ENVIRONMENT - APPOINTMENT: Mr Everingham (Chief Minister), by leave, moved -

That during the present session of the Assembly a committee to be known as the Sessional Committee on the Environment consisting of Mrs N. Padgham-Purich, Mr D.W. Collins, Mr T. Harris, Mr B. Collins and Mrs A.D. Lawrie be appointed.

That the committee be empowered to inquire into and from time to time report upon and make recommendations on all matters relating to uranium mining and processing activities and their effects on the environment within the Alligator Rivers Region.

That the committee have power to send for persons, papers and records, to sit during any adjournment of the Assembly and to adjourn from place to place.

That the committee be empowered to authorize the release of transcripts of evidence taken during public hearings and to publish information pertaining to the Committee's activities from time to time.

Debate ensued.

Question put and passed.

16. SUSPENSION OF STANDING ORDERS - INTRODUCE BILLS WITHOUT NOTICE: Mr Robertson (Minister for Education), by leave, moved -

That so much of standing orders be suspended as would prevent the introduction of Bills at this sittings without notice.

Question put and passed.

17. JABIRU TOWN DEVELOPMENT BILL 1980 (Serial 29): Mr Everingham (Chief Minister) presented the Bill which was thereupon read a first time.

Mr Everingham moved -

That the Bill be now read a second time.

Debate adjourned (Miss D'Rozario) and the resumption of the debate made an order of the day for a later hour.

18. UNIVERSITY (INTERIM ARRANGEMENTS) BILL 1980 (Serial 13): Mr Robertson (Minister for Education) presented the Bill which was thereupon read a first time.

Mr Robertson moved -

That the Bill be now read a second time.

Debate adjourned (Mr B. Collins) and the resumption of the debate made an order of the day for a later hour.

19. LEPROSY AMENDMENT BILL 1980 (Serial 6): Mr Tuxworth (Minister for Health) presented the Bill which was thereupon read a first time.

Debate adjourned (Mr B. Collins) and the resumption of the debate made an order of the day for a later hour.

20. CRIMINAL LAW CONSOLIDATION AMENDMENT BILL 1980 (Serial 12): Mr Everingham (Chief Minister) presented the Bill which was thereupon read a first time.

Mr Everingham moved -

That the Bill be now read a second time.

Debate adjourned (Mr Isaacs) and the resumption of the debate made an order of the day for a later hour.

21. HOUSING AMENDMENT BILL 1980 (Serial 14): Mr Robertson (Minister for Lands and Housing) presented the Bill which was thereupon read a first time.

- 4. DARWIN CYCLONE TRACY RELIEF TRUST FUND MONTHLY REPORTS, NOVEMBER 1979 TO JUNE 1980: Mr Everingham (Chief Minister) laid on the Table copies of monthly reports from November 1979 to June 1980.

Mr Everingham moved -

That the Assembly take note of the Reports

and was granted leave to continue his remarks at a later hour.

Debate adjourned and the resumption of the debate made an order of the day for a later day.

5. MESSAGE FROM ADMINISTRATOR: Mr Speaker read the following message from His Honour the Administrator:

I, JOHN ARMSTRONG ENGLAND, the Administrator of the Northern Territory of Australia, pursuant to section 11 of the Northern Territory (Self-Government) Act 1978 of the Commonwealth, recommend to the Legislative Assembly a Bill entitled the Appropriation Bill 1980-81 to provide for the appropriation of certain sums out of the consolidated fund for the service of the year ending on 30 June, 1981.

6. STATUTE LAW REVISION BILL 1980 (Serial 11): Mr Everingham (Chief Minister) presented the Bill which was thereupon read a first time.

Mr Everingham moved -

Debate adjourned (Mr Isaacs) and the resumption of the debate made an order of the day for a later hour.

7. PUBLIC SERVICE AMENDMENT BILL 1980 (Serial 27): Mr Everingham (Chief Minister) presented the Bill which was thereupon read a first time.

Mr Everingham moved -

That the Bill be now read a second time.

Debate adjourned (Mr Isaacs) and the resumption of the debate made an order of the day for a later hour.

 SUSPENSION OF STANDING ORDERS - THREE BILLS TOGETHER: Mr Tuxworth (Minister for Mines and Energy) moved -

That so much of standing orders be suspended as would prevent three Bills relating to industrial safety -

- (a) being presented and read a first time together and one motion being put in regard to, respectively, the second readings, the committee's report stages and the third readings of the Bills together; and
- (b) the consideration of the Bills separately in the committee of the whole.

The motion having been supported by an absolute majority, Mr Speaker declared the question resolved in the affirmative.

10. MAGISTRATES AMENDMENT BILL 1980 (Serial 23): Mr Everingham (Chief Minister) presented the Bill which was thereupon read a first time.

11. ELECTRICITY COMMISSION AMENDMENT BILL 1980 (Serial 24): Mr Tuxworth (Minister for Mines and Energy) presented the Bill which was thereupon read a first time.

Debate adjourned (Miss D'Rozario) and the resumption of the debate made an order of the day for a later hour.

12. APPROPRIATON BILL 1980-81 (Serial 25): Mr Perron (Treasurer) presented the Bill the subject of Message No. 1 from His Honour the Administrator and the Bill was thereupon read a first time.

Mr Perron moved -

Debate adjourned (Mr Isaacs) and the resumption of the debate made an order of the day for a later hour.

13. EDUCATION AMENDMENT BILL 1980 (Serial 30): Mr Robertson (Minister for Education) presented the Bill which was thereupon read a first time.

Mr Robertson moved -

That the Bill be now read a second time.

Debate adjourned (Mr Isaacs) and the resumption of the debate made an order of the day for a later hour.

14. PAY-ROLL TAX AMENDMENT BILL 1980 (Serial 26): Mr Perron (Treasurer) presented the Bill which was thereupon read a first time.

Mr Perron moved -
